1. NONCONFORMANCE TO SPECIFICATIONS

The bidder should conform to the specifications. Nonconformance with the proposal form and required information provisions of these specifications may be cause for rejection of the bid. Nonconformance of the successful bidder's performance, or nonconformance of the asphalt storage tank, may be cause of cancellation of the purchase agreement, rejection of the bid and bidder's proposal, return of the delivered unit and associated equipment to the bidder at no cost to the State of West Virginia, and recovery by the State of any payment to the bidder under the relevant purchase agreement.

II. IDENTIFICATION OF THE ASPHALT STORAGE TANK BEING PROPOSED

The bidder shall identify the asphalt storage tank by manufacturer, model, series, and year of manufacture in his proposal so as to enable identification by the West Virginia Division of Highways in the manufacturer's sales literature on the proposed asphalt storage tank. The bidder shall submit complete descriptive literature fully describing the proposed unit, to establish that he is bidding on the manufacturer's most current model, including latest engineering improvements, which have been, or shall imminently be, regularly advertised and sold on the open market. The description of the asphalt storage tank shall also be sufficient to assure the Division of Highways that specifications will be met without improvising, modifying or augmenting a basically standard horizontal asphalt storage tank beyond those variations contained in the manufacturer's regularly advertised specifications. The unit specified herein and offered in this quotation shall be manufactured after October 1, 2000, and clearly identified and marked with date of manufacture.

III. DELIVERY POINT AND DELIVERY SCHEDULE

Delivery of the asphalt storage tank shall be made within sixty (60) calendar days of the date of the purchase agreement by the successful bidder, to the West Virginia Division of Highways: Harrisón County, Gore (US 19), West Virginia.

IV. PRE-SERVICE

The asphalt storage tank shall be completely serviced, all equipment installed and all adjustments made which are required to prepare the unit ready for immediate and continuous operation upon delivery.

V. PARTS AND SERVICE DISCOUNTS

The bidder should specify the amount of discount he will grant to the West Virginia Division of Highways, on parts and labor, for the second year the Division has the asphalt storage tank in operation. Discount on labor should be that allowed on the usual and normal shop rate charged to retail customers for the same type of work done. Discount on parts should be that percentage granted on manufacturer's list price.

DESCRIPTION:

Specifications will be to describe a 7,000 gallon Vertical Mounted Tanker. To be used for storing, heating and pumping various types of road asphalt. Tank shall be manufactured in accordance with ASME and AWS standards.

TANK:

Tank shall have a capacity of 7,000 gallons. Shall be round in cross section and constructed of ¼" type A36 steel. Shell tank will be equipped with flanged head construction of 1/4" A36 steel. Tank to be vertically mounted. Tank to be equipped with a 24" full opening manhole with a steel access ladder (inside and out). Will be equipped with 4" overflow pipe and emergency venting. Fittings will consist of a 3" drain plug, 2- 3" discharge fitting with a hot oil ball valve with electric heat tape to allow for cool weather operation. Tank to be equipped with a bottom sump clean out and a 24" side cleanout with removable cover. System to include a full sweep agitator driven by a gear reduced electric motor. Agitator shall have a low temperature and low level shut down. To also include a 7 day programmable time to prevent materials from separating. Unit to include tank stand for gravity unloading.

HEATING SYSTEM:

Heating system shall consist of 12-1000 watt strip type heaters installed on the bottom half of the product tank with access to replace individual heaters. Tank to have float type oil level indicators with scale in gallons and liters.

CONTROLS:

The electric elements will have push button temperature controls to monitor temperature of material in tank and control heaters. Temperature range for the automatic controls will be from 0° - 550° F. System to include a separate high temperature shut down in the event of over heating.

CONTROL BOX:

All temperature controls, pump controls and power disconnect to be installed in a weather tight enclosure with lockable cover.

INSULATION:

The entire tank shall be insulated with 4" of 1½" density fiberglass insulation.




