LCMS Triple Quadrupole System

LC/MS triple quadrupole system, API module and ESI housing; control software, PC, 1 MS40+ foreline pump, HPLC pumps, HPLC autosampler, HPLC column, installation, onsite training of a minimum of 5 days of on-site training to cover methods set-up and fine tuning, maintenance, quantization, report generation, Full Scan and SIM combined methods development and 1-year warranty.

- The ESI and APCI spray needles must be orthogonal to the capillary interface in order to eliminate contamination of the MS. Ionization modes must include: Electrospray Ionization (ESI).
