Phase 2 consisted of a massive underground electrical and telecommunication ductbank design as well as critical domestic water service and storm and sanitary system upgrades to meet the facilities current and future infrastructure demands.

Phase 3 design services were focused on the extensive renovation of the North-South Building and conversion into two large dormitory housing wings with campus support elements such as main visitor entrance, visitation, intake and processing, staff meeting space, and staff locker areas being housed in the central core of the structure.

Still additional phases of the project have included significant upgrades to the security fencing systems and much needed additions and renovations of the dining hall facility to support potential increases in campus population through additional housing projects. All told, Silling Associates and our consultants have master planned over 250,000 square feet of space and have seen through to completion nearly 125,000 square feet of construction through the phases noted above.
