REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. Addendum #1

- Item 1: The Contractor's Bid Sheet has been revised and is included with this addendum. The revision is the quantity of Item 9.1 Wet Seal. It has been reduced from 10 to 9.
- Item 2: Add the following to the Technical Specifications Section 1.0:
- "For the culvert crossing of a small stream on the access road (Thaxton Road) to the site near the intersection with Route 24, the Contractor shall place one inch thick steel plating a minimum of 25 feet long and as wide as the existing road (approximately 10 feet) over the culvert to provide protection. The steel plating shall be removed at the completion of the project and shall be retained by the Contractor. This shall be considered incidental to the Pay Item 1.0, "Mobilization and Demobilization".
- Item 3: Remove the first sentence of Section 7.2.1, "Stone" and replace with the following:
- "Stone for the riprap channel, toe drains and other uses except for the mine seals shall be hard, durable rock. The stone for the mine seals shall be hard, durable non calcareous rock."
- Item 4: The Contractor will have 90 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 90 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.
- Item 5: Q) Will access road to the site be stoned?
- A) Only as shown on the plans which is the owner's driveway.
- Item 6: Q) Is there an easement through the property?
- A) DEP has access to the site which will be maintained in as good or better condition.
- Item 7: Q) Has the slide actually broke open?
- A) There is a small scarp up slope and a small bulge near the bottom.
- Item 8: Q) Where is slip located?
- A) Slip is located over the side of the hill and as indicated on the construction plans.
- Item 9: Q) Are the portals located on the same tax parcel number?
- A) No

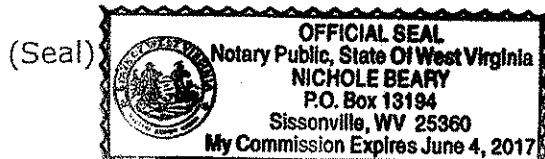
