Item 1: The contractor will have 90 days from the date of the Notice-to-Proceed to complete construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 90 days. However, the total performance period will be 365 days from the date of the Notice-to-Proceed for invoicing purposes.

Item 2: Q) Is there access between the two work sites on the side of the hill?

A) There should be no disturbance in this area.

Item 3: Q) Are any of the ditches open?

A) Yes, however there are two proposed underdrains for this site also.

Item 4: Q) Are all the proposed ditches rock riprap?

A) Yes

Item 5: Q) There is approximately 1,000 feet of existing pipe to be cleaned out. Who decides when the pipes are clean?

A) DEP personnel will give approval when the pipes are considered cleaned.

Item 6: Q) Will the existing pipes be removed and cleaned?

A) No, the pipes are to be flushed out.

Item 7: Q) What are the sizes of the existing pipes?

A) As shown on the plans, the pipes range in size from 12-inch, 18-inch and 24-inch.

Item 8: Q) Where is soil cover to be placed?

A) Over the wet mine seals.

Item 9: Q) How deep are the underdrains?

A) The underdrain is 2 ft x 3 ft. The proposed underdrain profiles are in the plans showing the existing ground and depth.

Item 10: Q) What drainage goes behind the house on the west end of the site?

A) Underdrain No. 1.

Item 11: Q) Where will excavated material from ditches be placed?

A) Material can be utilized for soil cover on wet mine seals. Off-site disposal area for excess material must be obtained by the contractor as stated in the Special Provisions, Section VII in the specifications.

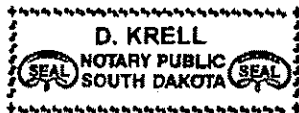

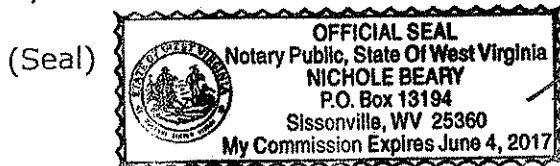
