**Addendum #1 - Questions During Pre-Bid Meeting
For DEP 14702
Fairmont East Mine Drainage Project**

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) Q. Do you have all of the utilities shown on the plans?
A. No. The contractor should call Miss Utility for location of utilities.
- 2.) Q. Do you anticipate any being encountered.
A. That is definitely a possibility.
- 3.) Q. What is needed to be done with the pipe that exits the current drop inlet that is to be replaced?
A. The water is intended to be rerouted by the new drop inlet installation such that it goes down Harr Street and not Palantine Avenue.
- 4.) Q. Can the drop inlets be installed on a slope in the street to match the existing grade?
A. No. They are to be installed vertical with the top sloped to match the existing grade.
- 5.) Q. Is there an existing storm drain in Harr Street?
A. No.
- 6.) Q. What is the width of the right of way to access the piezometers?
A. The right of way is the construction limits and can be scaled off of the drawings.
- 7.) Q. Is there any work to be done above the catch basin in the yard?
A. A short section of 15" CPP is required to be connected to the existing pipe.
- 8.) Q. Is there any other access to the piezometers?
A. No. Access is as shown on the drawings.
- 9.) Q. Who will be responsible for performing the relocation of utilities if it is necessary?
A. The contractor; not the city.
- 10.) Q. Does the city have any vacant lots nearby that can be used for a staging area?
A. No.

The Contractor shall have 60 days from the date of the Notice to Proceed to complete Construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 60 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.



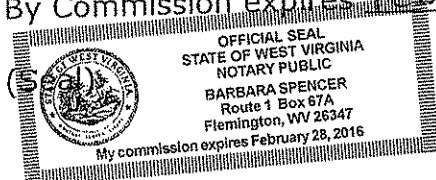
