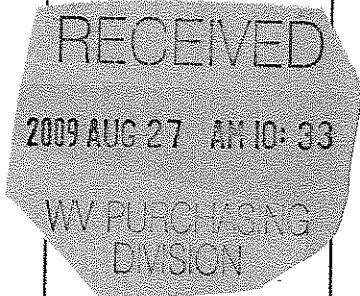

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

**Addendum #1 - Questions During Pre-Bid Meeting
For DEP 14723
Katy Lick (Rardin) DS Project**

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) **Q.** Does the gas line relocation require getting a price quote from the utility company?
A. No, this is a service line.
- 2.) **Q.** Do we only relocate what's in the construction limits?
A. Yes.
- 3.) **Q.** The cut and fill doesn't balance. Does this mean we have to haul some material off-site?
A. Yes, there will be material hauled from the site.
- 4.) **Q.** Does the basement extend all the way under the back section of the house?
A. No.
- 5.) **Q.** How far out from the house is the underdrain located?
A. Approximately 12 feet to 15 feet at the closest point.
- 6.) **Q.** Is it wet or does it dry up during the summer?
A. Not sure at this time.
- 7.) **Q.** Can the road to the gas well be utilized for access?
A. It is not shown to be used as access.
- 8.) **Q.** Do we have an estimate of how much material needs to be hauled off site?
A. No.
- 9.) **Q.** Do you have x-sections on the excess material disposal area?
A. Yes. The maximum and minimum x-sections are given in the plans.
- 10.) **Q.** Why do you have a maximum and minimum grade line for the highwall fill area?
A. The minimum is to establish positive drainage, the maximum is to protect against over loading the slide material.
- 11.) **Q.** Will there still be excess material to haul off if you go to the maximum grade line?
A. Yes.
- 12.) **Q.** Do you have an another waste area identified on the plans?
A. No.

- 13.) Q. Does the 2100 CY of unclassified excavation include the excavation from the underdrain installation?
A. No.
- 14.) Q. Can we waste material on the adjoining property?
A. No off site spoil areas were sought out.
- 15.) Q. What is the stake beside the house?
A. Marks the location of bore hole #2.
- 16.) Q. How deep is the coal at the house?
A. Bore hole logs are in the specification.
- 17.) Q. Does the topsoil around the house need to be stripped and stockpiled for redistribution?
A. Yes.
- 18.) Q. Does the existing pipe that is to be removed tie into anything?
A. Not known.
- 19.) Q. Does the drainage for the pipe installation just go down the existing channel?
A. Yes.

The Contractor shall have 60 calendar days from the Notice to Proceed to complete construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 60 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.

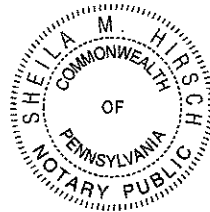

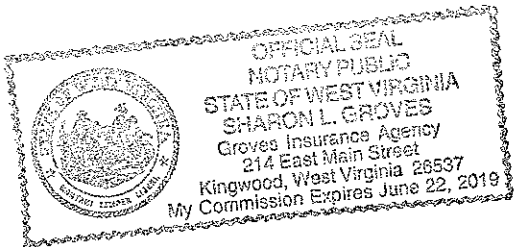
