1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the **West Virginia Code** and the **Legislative Rules** of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the **West Virginia Code**.
8. Vendor preference will be granted upon written request in accordance with the **West Virginia Code**.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the **Legislative Rules** of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

**Addendum #1 - Questions During Pre-Bid Meeting
For DEP 14772
Crooked Fork Highwall #2 Project**

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) Q. How is this project mine related?
A. There is an existing highwall on the site at the upper end of the existing channel. This highwall has contributed to extra runoff and as caused the erosion on the existing stream channel.
- 2.) Q. Is there a width requirement on the temporary stream crossing?
A. No the width will depend on your needs to have either one lane or two lanes of access to the work area.
- 3.) Q. Is the stream work called natural stream design?
A. No. This is a rip rap lined channel that has several bends and a low flow vee notch in the bottom to simulate a natural stream flow.
- 4.) Q. What is the specification on the stone that will be used in the ditch?
A. The gradation specification is on the ditch detail sheet. The rock size is d50=12" and the rock will be limestone with a calcium carbonate equivalent of 70%.
- 5.) Q. Will the trees and brush be burned?
A. Yes but all necessary permits are required.
- 6.) Q. Are there trees that need replaced by agreement with the landowner?
A. No
- 7.) Q. Is there only 6" of rock below the vee notch on the 12' channel?
A. No there will 18" of rock required beneath the vee notch.
- 8.) Q. Does the excavated material from the new ditch get wasted on site?
A. Yes
- 9.) Q. Will the new stream bed intersect with the existing stream bed?
A. Yes and drainage must be maintained at all time from the stream bed above.
- 10.) Q. Is the channel crossing permanent?
A. Yes. The stream crossing is temporary but the channel crossing permanent.
- 11.) Q. Do any of the ditches require grouting?
A. No
- 12.) Q. Do you have to follow the stream layout as shown on the plans or can it vary?
A. You must follow the layout on the plans.

- 13.) Q. If rock is encountered during the ditch installation do we have to over excavate?
A. The rock must be excavated to the grade shown on the plan. No additional payment will be given for rock excavation.
- 14.) Q. Are the trees along the channel in front of the house to be saved?
A. Yes
- 15.) Q. Is the 4" plastic line at the upper end of the project have gas in it?
A. We do not think it is an active line. The line can be worked around to install the channel.
- 16.) Q. Can any rock on site be used?
A. No

This project shall be bid in accordance with the attached **REVISED Bid Schedule and the REVISED plans.**

The Contractor shall have 90 days from the date of the Notice to Proceed to complete Construction activities on the project. 



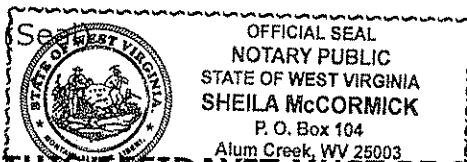

Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules.
