1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.

**Addendum #1 - Questions During Pre-Bid Meeting
For DEP 14973
Anglin's Run #1 Project**

The Contractor's work hours for this project will be 7:00 a.m. to 7:00 p.m. Monday through Saturday. Work on Sunday and major holidays shall not be allowed on this project.

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

There are 8 piezometers located at Anglins Run. The bore logs indicate which bore locations have piezometers.

The revegetation of Access Road #2 does not have a separate pay item but is included in Item 6.0, "Revegetation". (As stated in 4.1.3 of the Specifications)

Section 4.1.3 also states that Access Road #2 contains 1 12 foot wide stone overflow at Station 28+12 which shall contain 4" of 1 ½" Crusher Run and be paid under Item 4.3, "Driveway Resurfacing".

The 40 Tons of gravel was allotted for the overflow as well as the driveway resurfacing. The resurfacing was intended to cover mainly the parking portion of the driveway, possibly extending down the hill as needed (but no more than half of the driveway).

The straw bale dike sediment control shown on the plans shall be revised to silt fence sediment barrier.

The bidders are advised that a portion, if not all, of the project lies within the city limits of Philippi, WV. The successful bidder shall contact the City of Philippi, regarding the requirements for paying B & O taxes on the construction activities that will take place within the city limits.

The Contractor shall have 90 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 90 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.
