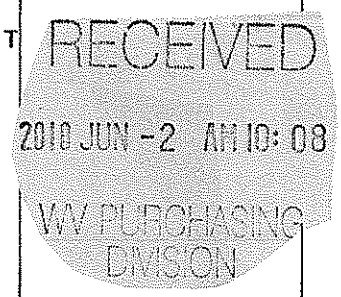

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

Add Specification 6.6.4 – This work shall also include requirements listed in NPDES attachment “VEGETATIVE PRACTICES”. This work shall be incidental to the lump sum payment for Pay Item 6.0, Revegetation”.

Specification 8.1 – Remove last sentence “This work shall also include the regrading of access roads from drilling activities.” The landowners have requested that these access roads remain in place.

Specification 8.4.1 – Remove “The existing drill roads shall be regraded at the location and configuration as shown on the drawings.”

Eliminate Pay Item 8.0, “Drill Road Reclamation”, per lump sum.

Specification 10.3 – Add “Additional existing open drill holes not containing monitoring wells are located on the drill roads. These holes shall be abandoned by a person who has been certified by the State of West Virginia in accordance with 47 CSR59. “Monitoring Well

Regulations” and by the same method as abandoning the monitoring wells. Access to the monitoring wells and drill holes shall be performed without heavy equipment to minimize disturbance to the existing grassed drill roads. Damage to the grassed drill roads shall be repaired as approved by the WVDEP and revegetated according to Section 6, “Revegetation” of the construction specifications.

Specification 10.4 – Last sentence – Now Reads “Monitoring well abandonment shall be included in the price of mine seals.” Revise to read “Monitoring well and drill hole abandonment shall be included in the price of mine seals.”

REVISIONS TO DRAWINGS

Revised Drawing 3 of 4 is attached.

Drawing 4 of 4 – Delete SEDIMENT CONTROL DETAIL, SILT FENCE DETAIL and DRILL ROAD REGRADE DETAIL.

QUESTIONS AND ANSWERS

Q: Will there be separate silt fence and straw bale bid items?

A: No. They are both paid under "Sediment Control Barrier".

Q: Does the road from the blacktop up get stone?

A: Yes. At the completion of the work the existing driveway will get covered with stone as outlined in the specifications and at the location shown on the drawings.

Q: Does the rock have to come from a commercial source?

A: No but the rock can come from a commercial source. Rock used must meet specifications whether from a borrow site or a commercial source.

Q: Disturb the least amount of trees?

A: Yes; as outlined in the specifications.

Q: What about the guy (resident) at the bottom of the hill? We may discharge water on him (when excavating mine openings).

A: The Contractor is responsible for releasing water in a controlled manner as outlined in Specification 10.3.

Q: Where do the grass lined channels discharge?

A: At the location shown on the drawings.

Q: How big are the splash pads?

A: Size is shown on the drawings.

VEGETATIVE PRACTICES

Except as noted below, stabilization measures shall be initiated as soon as practicable in portions of the site where construction activities have temporarily or permanently ceased, but in no case more than seven days after the construction activity in that portion of the site has permanently ceased.

- Where the initiation of stabilization measures by the fourth day after construction activity temporarily or permanently ceases is precluded by snow cover, stabilization measures shall be initiated as soon as conditions allow.
- Where construction activity will resume on a portion of the site within 21 days from when activities ceased, (e.g., the total time period that construction activity is temporarily halted is less than 21 days) then stabilization measures do not have to be initiated on that portion of the site by the seventh day after construction activities have temporarily ceased.

Areas where the seed has failed to germinate adequately (uniform perennial vegetative cover with a density of 70%) within 30 days after seeding and mulching must be reseeded immediately, or as soon as weather conditions allow.

Diversions must be stabilized prior to becoming functional.

MAINTENANCE & INSPECTION

At a minimum, all erosion and sediment controls on the site will be inspected at least once every seven calendar days and within 24 hours after any storm event of greater than 0.5 inches of rain per 24-hour period.

All controls should be cleaned out when sediment reaches one half the sediment capacity of that control.

Inspection and maintenance records must be kept onsite.

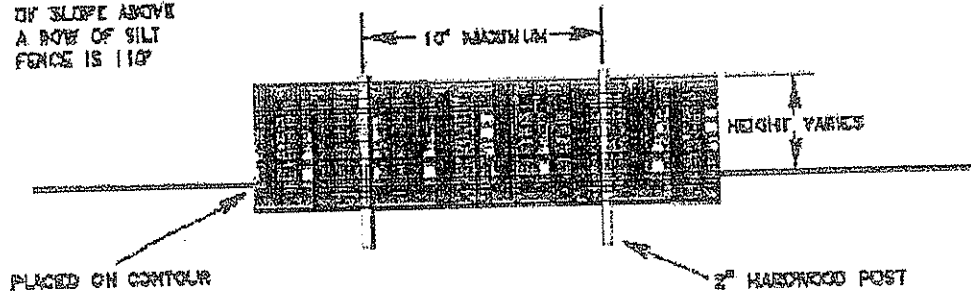
EROSION & SEDIMENT CONTROL CONSTRUCTION SEQUENCE

1. Install stabilized construction entrance as shown on site plans.
2. Install perimeter sediment control devices as shown on site plans.
3. Clear and grub site.
4. Provide sediment control for any topsoil stockpiles.
5. Commence rough grading of site. Continue to maintain and inspect all erosion and sediment controls.
6. Install additional erosion and sediment controls as shown on site plans.
7. Fine grade site.
8. Permanently seed and mulch all disturbed areas within 7 days of reaching final grade.
9. Upon completion of project including adequate stabilization, remove all remaining erosion and sediment controls.

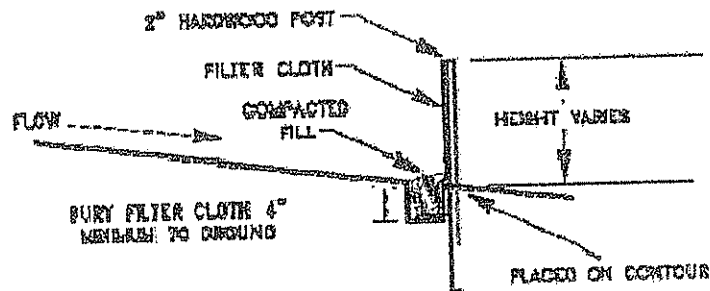
FIGURE 3.27.2

SILT FENCE

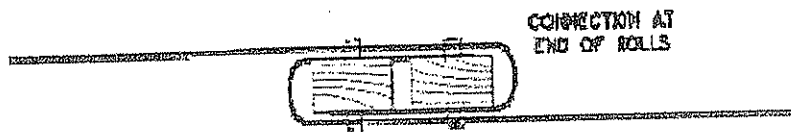

FENCE IS 110'



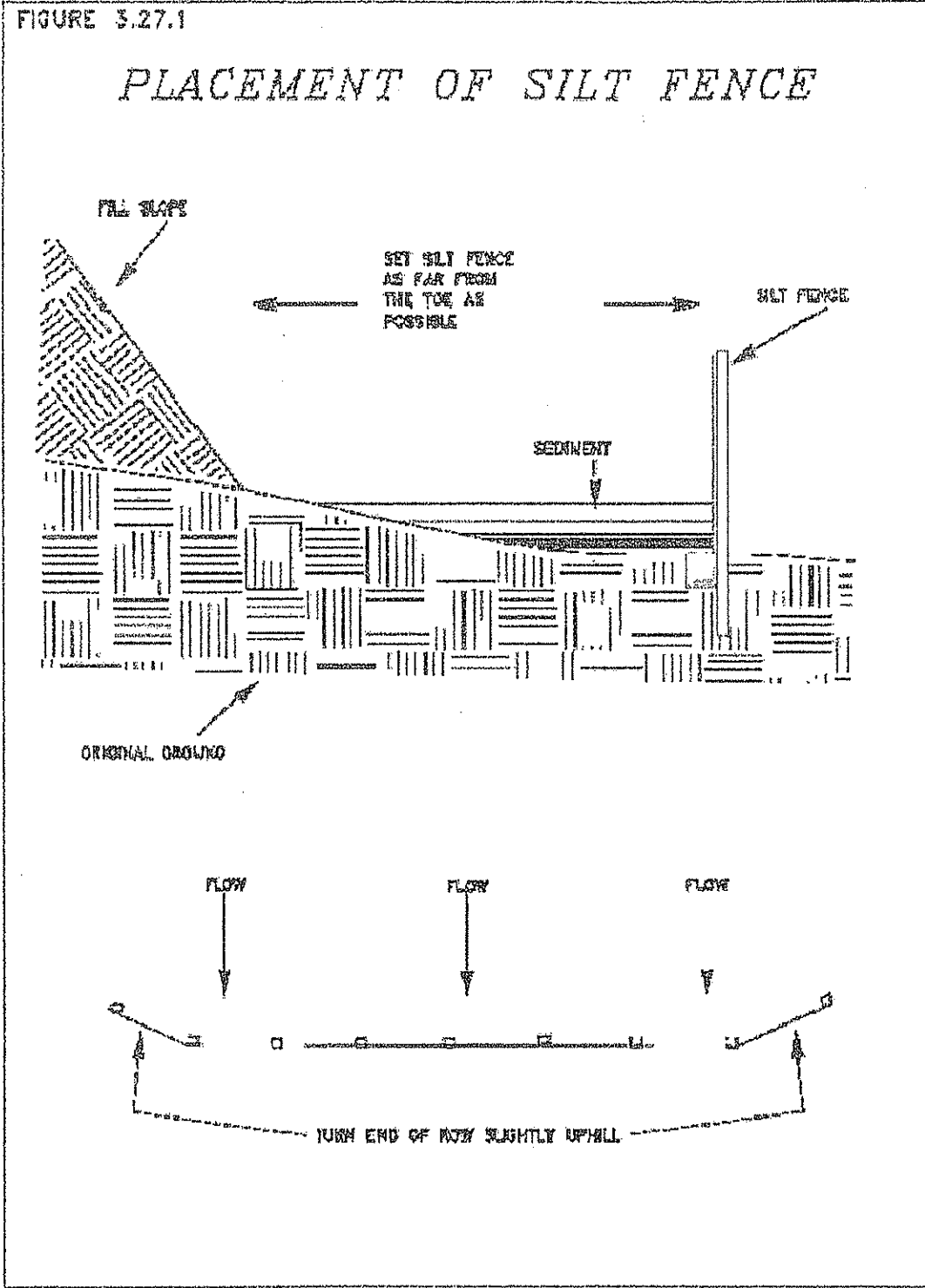
FRONT ELEVATION

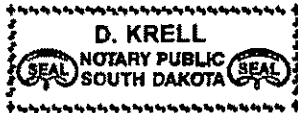

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
