REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. The West Virginia Division of Juvenile Services is soliciting bids for an Open-Ended Fresh Produce Contract to be used at our facilities across the State. The Division will accept bids on a location basis or statewide basis. The Division reserves the right to Award the contract on a location or statewide basis according to vendor availability.

Specification Guidelines

Fruits and Vegetables shall be fresh and of acceptable quality.

At a minimum there will be one (1) Delivery date per week for small facilities and two (2) or more delivery dates for the larger facilities. A regularly scheduled delivery time shall be maintained by the vendor on specified days of the week. These specified days will be determined by vendor availability.

Each Division of Juvenile Services Facility has a different population range. The Larger facilities will be noted on the Bid Form (L)

Smaller Facilities will require some reduction in pack size on various items. These reduced package sizes have been included on the bid form. These smaller facilities will be noted on the Bid Form. (S)

The vendor shall assume responsibility to deliver produce to a fixed and designated dry and sanitary place designated by the receiving agency. Acknowledgment of deliveries will only be made by an authorized receiver.

The receiver reserves the right not to accept any produce that is found to be damaged or of inferior quality.

Pricing

Bid price on all items will be Cost plus a Set percentage (%) mark-up.

The successful bidder must make available all items in the bidders Inventory to be purchased even though the items are not listed on the bid sheet.

Documentation supporting Vendor cost must be submitted with each invoice.

Award will be made to overall low bidder per location.

ALL Delivery CHARGES shall be included in the bid price.
