Q: In reviewing the requested minimum specifications for the tractors I would like to request consideration for reducing the engine and PTO horsepower by (1) unit to allow for a broader range of competitive tractors. This historically will save a considerable amount of cost to the DNR and for the purpose these tractors will be used the (1) horsepower should not be an issue.

A: The West Virginia DNR is agreeable to the request to reduce the engine and PTO horsepower by one (1) unit to a minimum engine horsepower of 75 HP and a minimum PTO horsepower of 61.

Q: Within the advertised requirements I do not see where this RFQ requests a bucket for the loader. Is this correct or an over-sight?

A: The terms loader and bucket are often used interchangeably. Subsequently, the tractor should include the following equipment: Must have a free standing quick attachment system front end loader/bucket with a minimum capacity of 2,000 lbs., and a minimum front end lift height of 122 in. Loader must also include two open centers, mid-mounted loader valves with a four-way joystick

PURCHASING AFFIDAVIT
