

At this time we are running one Leitch Integrator SD SDI video and one Leitch Integrator AES audio tub, both 64 input by 32 output. We use the Harris/Leitch X-Y Control Bus running on coaxial cable for remote panels and inter tub connection. We currently program our system with a serial connection to one of our tubs. At this time we have an assortment of controllers: Leitch ABA2 XYp & 64x1p and Harris RCP-64x1p remote panels, but are not limiting our system to only these units. All programming and configuring of the system is done with Harris/Leitch Router Mapper software.

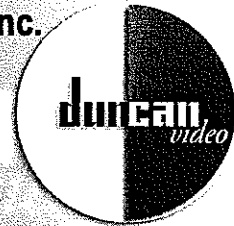



PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.
