The West Virginia Educational Broadcasting Authority (WVEBA) is conducting a Request for Quotations for a total of four (4) rack mountable multi-format Audio Monitors. The units shall meet the specifications listed below: Wohler #AMP2-S8MDA or equal.

Specifications must be equal to or exceed items listed below

I. Equipment Requirements

Audio Monitor: Wohler #AMP2-S8MDA, or equal

- * Rackmountable: Shall be 2 RU in height & install into an industry standard 19" wide rack
- * Monitoring capability: shall monitor signals from HD-SDI, SD-SDI, AES/EBU, & Analog inputs
- * Shall have front panel summing of any combination of up to 8 channels to the left and/or right speakers and selected
- * Shall have eight High-Resolution 53-segment tri-color bargraph audio level meters to provide instantaneous visual level monitoring
- * The audio amplifier section shall feature:

five high performance transducers driven by three power amplifiers two amplifier/driver combinations to handle midrange and high frequency information in stereo

the third center channel reproduces information below the 500 Hz crossover point thru a woofer speaker

- * Shall have audible indications of phase/polarity problems
- * Shall have a 2.1 Speaker System with output limiter circuit to protect speakers
- * Shall have a front headphone output jack that mutes speakers
- * Shall have magnetic shielding, <0.8 gauss any adjacent surface, for placement next to video monitors and sensitive equipment

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt' means any assessment, premium penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon

Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement
