Good Faith

Value-Add Reinsurance

Considering the almost \$900,000 in costs incurred by the Authority for inmate claims in excess of contracted catastrophic limits, coupled with the favorable provider discounts allowable by West Virginia law, we believe the Authority is a likely a good fit for a reinsurance policy to assist in mitigating risk and financial cost variations.

For the majority of our 43,000 inmate patients, CCS protects our clients and CCS by purchasing catastrophic reinsurance. These policies cover costs over a deductible that is negotiated annually. For example, in Durham County our policy, which costs less than \$90,000 annually, reimbursed over \$300,000 which prevented a huge financial hit for CCS and Durham. These policies will absolutely help mitigate risk. We would need a few additional pieces of information to obtain a quote but CCS has exclusive arrangements with underwriters which guarantee us a preferred price due to our past successes in Utilization Management and Network Development. As another example, Monmouth County priced a reinsurance policy on their own, prior to putting their healthcare contract out to bid. The best bid that came in was still too expensive for the County to agree to CCS was able to cut the rate, from the exact same underwriter, by 50 percent because of the underwriter's confidence in our ability to manage costs

We would simply need your 2008, 2007 and 2006 high-dollar claims data to obtain quotes. Again, this is a service unique to CCS because of our exclusive reinsurance partnerships which allow us to provide significantly reduced premiums versus others in our industry. Said another way, the underwriters put their money where our mouth is!
