GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.

Specifications

Purpose: To establish a purchase order to provide the West Virginia Division of Highways with 7/8" diameter post-tensioning rods with nuts and washers to be used on Bridge # 36-1-0.01, Trout Run Bridge.

1.0 DEFINITIONS

- A. The "Agency" shall be defined as the West Virginia Division of Highways.
- B. The "Vendor" shall be defined as the successful bidder.
- C. The "Purchase Order" shall be defined as the binding agreement that is entered into between the State of West Virginia and the Vendor to provide the services as herein specified.
- D. "Mandatory Requirements: The terms "must", "will", "shall", "minimum", "maximum", or "is/are required" identify a mandatory item or factor. Decisions regarding compliance with any mandatory requirements shall be at the sole discretion of the State.

2.0 SCOPE OF WORK

The successful Vendor shall provide 22-Galvanized 20mm, 7/8" Dia., Threaded Bar, GR160 shipped 29' long, 44-Galvanized Hex Nuts for the 20mm, 7/8", GR160 bar, and 44-Galvanized Flat Washers for the 20mm, 7/8", GR160 bar.

2.1 Technical Requirements:

- 2.1.1 Post-tension rods, washers and nuts provided shall be in accordance with West Virginia Division of Highways Standard Specifications Roads and Bridges, adopted 2010 and the current Supplemental Specifications and the attached control prints. www.transportation.wv.gov/highways/engineering/Pages/publications.aspx
- 2.1.2 Rods shall be as manufactured by Dywidag Systems International, USA Inc. or equal.

2.2 Freight

- 2.2.1 All shipments are to be FOB Destination.
- 2.2.2 The Vendor shall be responsible for all freight charges incurred as a result of the purchases under this Purchase Order.

- 2.3.4 Delivery will only be accepted during normal working hours 7:30 am to 4:00 pm, Monday Friday.
- 2.3.5 Delivery is an integral part of this purchase order and failure to comply will be cause to initiate a WV-82, Vendor Performance Form. This form will officially notify the West Virginia Division of Purchasing and the Vendor of unsatisfactory performance in the execution of this purchase order and the requirements herein.
