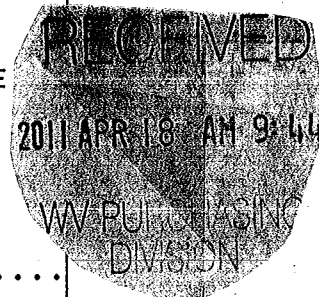

1. Awards will be made in the best interest of the State of West Virginia.
 2. The State may accept or reject in part, or in whole, any bid.
 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services.
 6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
 7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

The State of West Virginia hereby accepts a contract for the purchase and removal of accumulations of scrap metal from the West Virginia Division of Highways District 9 locations, in accordance with the following conditions:

In the process of removing the scrap metal, the successful bidder shall weigh each load on certified scales in the presence of a representative of the Division of Highways. The weight slip must be sent to the appropriate Division of Highways Comptroller and/or Highways Accountant.

All payments shall be made on a "per gross ton" basis for each of the various locations in the District on this contract. A gross ton is 2,240 pounds.

The successful bidder will be responsible for all equipment needed to load the scrap metal for removal from Division of Highways facility. Unless other arrangements have been made and approved by the Division of Highways, the scrap metal must be picked up within fifteen (15) days after notification. Failure to pick up scrap within the prescribed time limit can result in disposal by other means and forfeiture of contract.

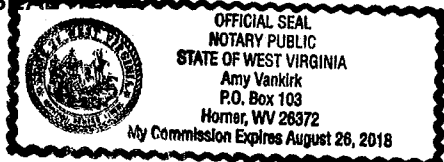

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.
