The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

- Q. Are sediment control details provided in the Plans for the SWPPP requirements?

- Q. Does the Contractor have to remove the tree slashings?
- A. Yes, but only within the construction work limits of the project.
- Q. Does the clearing & grubbing extend to the standing line of stumps at the edge of the field above the top of highwall?
- A. Yes.
- Q. What does the Contractor do with the posts that support the erosion eels in rock riprap and grouted riprap ditches at completion of the project?
- A. Cut them off @ the flow line.
- Q. Is the maximum allowable dimensions for boulders incorporated into the backfill 2'  $\times$  2'?
- A. Yes.
- Q. Is there a lot of garbage on-site to be removed incidental to the Site Preparation pay item?
- A. Yes.

### **COMMENTS:**

"Sediment Control devices (Brosion Eels© which are 9.5 inches by 10 foot long) shall be installed stacked two high as shown on the plans. In this instance the Contractor will be paid for 20 linear feet (2 X 10 foot long Eels) for "Item 5.3 Sediment Control Devices". In some instances four Sediment Control Devices at one location will be required to span wide drainage swales. In this installation two stacked Eels will be tightly butted against two additional stacked Eels for a total of four Eels at one location. In this instance the Contractor will be paid for 40 linear feet (4 X 10 foot long Eels) of "Item 5.3 Sediment Control Devices". Should the Contractor install a single Eel (1 X 10 foot long Eel) then he will be paid for 10 linear foot of "Item 5.3 Sediment Control Devices".



## PURCHASING AFFIDAVIT

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
