Addendum #1 - Questions During Pre-Bid Meeting

For DEP 15361

Monongah (Cain) Portals

The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

General Comments:

1. Paragraph #2 for Section 9.1 of Specifications now reads:

Site #2 - This work shall consist of dewatering the existing mine pool, excavating the mine opening, installing the 51" x 66" Bate Gate Mine Seal and backfilling the opening to near original grade.

Paragraph #2 for Section 9.1 of Specifications shall read:

Site #2 and Site #3 - This work shall consist of dewatering the existing mine pool, excavating the mine opening, installing the 51" x 66" Bate Gate Mine Seal and backfilling the opening to near original grade.

2. The existing road culvert located on Site #1 that is to be abandoned for the installation of the new 30" HDPE shall be fully grouted as part of the abandonment process. The cost of grouting the abandoned culvert shall be incidental to the installation of the new 30" HDPE as described under Section 7.1 Drainage Structures.

Questions:

1. Q. Will the water from the mines need to be treated?
A. Yes. The water must be treated to a pH of 6.0 to 9.0 during the dewatering process.
2. Q. How wide is the road stone on site #3?
A. The road stone will be 10' wide and 3" in depth. This will be the requirement for the stone at the completion of the project.
3. Q. Can we cross Booth Creek with our equipment to get to site #2?
A. No. No equipment will be allowed in the stream except for the area where the bridge is to be removed from the stream. We have 150 LF of stream access approved at that site.
4. Q. Will we clean up any of the trash on the bank below site #3?
A. No. The only trash that we will cleanup will be located inside the construction limits.

The Contractor shall have 150 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250.00 per day liquidated damages clause will be in effect after the 150 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.



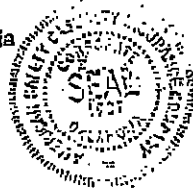
