# GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 12. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 13. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, is available online at www.state.wv.us/admin/purchase/vrc/hipaa.htm and is hereby made part of the agreement. - 15. LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, and the West Virginia Insurance Commission. The vendor must provide all necessary releases to obtain information to enable the director or spending unit to verify that the vendor is licensed and in good standing with the above entities.
- 16. ## Service Specifications

- Successful vendor must be able to provide all items listed on bid sheet.
- Vendors will provide samples upon request and samples will be sent to the WV Purchasing Division. Samples are to be received within ten (10) business days of request.
- The successful vendor must be willing to take the state purchasing card for payment or payments processed through the auditor's office. **Prompt Pay Discounts** for payments made on the purchasing card within 10 days of receipt of goods are encouraged and will play a part in the overall award decision.
- The successful bidder will have a <u>full time Regional Account</u>

  <u>Representative</u> servicing the state of West Virginia and to manage this contract. The representative will visit with applicable State of WV personnel on a quarterly basis at a minimum and more often as needed.
- The successful bidder will maintain a minimum of six weeks of inventory on hand at all times based on historical usage.
- The successful bidder will maintain <u>service levels of 98% or better</u> on time delivery. Delivery requirements are 14 business days or less for standard items/sizes from date of order.
- Warranty All products and product embellishments must be new and meet the specifications for which they are intended. Products will be warranted free from defects in materials and workmanship for a period of one year. Proper care and laundering are required by State of WV personnel in order to maintain the warranty terms.

- Returns: Non embellished goods in original packaging materials may be returned for a period of up to one year. There will not be a restocking fee for these returns.
- Successful bidder will have a dedicated account management team that will be responsible for administering the terms and conditions of this program.
   The team must be available Mon-Fri between the hours of 8:00 AM and 5:00 PM EST.

**Fabric:** Style: Perfection MTX-ECO Series TM or equal to with engineered stretch twill with Perfection X-Factor Technologies or equal to, featuring SwiftGaley Indestructible 5626/158 with H2 Tech Dual Action (Hydrophilic/Hydrophobic), Flex, and UltraDye Enhancements or equal.

**Color:** Dark Navy utilizing H2 UltraDye Technology or equal to for enhanced color depth and color retention. All available colors but at a minimum must offer a solid Dark Navy and Dark Brown with a tan stripe down the outside leg seam.

Fiber Content: 65 % polyester 35% combed cotton

Weave: 2x1 Twill with engineered Stretch

Weight: 7.5 oz. /square yard

Construction: 90 warp x 50 filling

**Tensile Strength:** 160 x 90 Lbs.

**Design:** The frousers shall be available in a men's and women's relaxed fit uniform trouser pattern. Uniform trouser shall have a plain front with two quarter top pockets. Two, side cargo pockets. Top-stitched back pockets with triangle bar-tacks, left pocket has tab to button. Zipper fly front with French fly. One-piece ECG or equal diamond-gusset crotch. Two inch wide expandable waistband, with dropped belt loops. Straightleg bottoms. CREASET® super silicone creases or equal.

Pockets: The front pockets are quarter top style, with a minimum 6 1/2" opening and 6" depth, measured from the bottom of the opening. The front pocket bags are double tipped and shall be stitched, turned and re-stitched. The inside front pocket facing shall be a separate piece of shelf material finishing no less than 1 1/4" wide. Each front pocket shall have a straight bar-tack at the top and a triangle bar-tack at the bottom of the opening. There is a double-compartment cargo pocket with a flap centered on the out-seam, approximately 9 1/2" below the waist seam. Each cargo pocket measures 7" wide x 7 3/4" long and has mitered corners. The front compartment has a 1-1/2" stitched box pleat. The top of the flap is stitched to the pocket and has horizontal bartacks in the upper corners. The flap closes with three pieces of Velcro loop: a 1"x1" piece in each lower corner and a 1"x1-1/2" strip at the point to match the Velcro hook placement on the pockets. The back compartment is accessed by a hidden 6" nylon zipper with molded plastic teeth (1-1/8" behind and below the upper edge of the flap.) Zippers open in a front-toward-back direction. Velcro must be durable and washable. The back pockets have 5-1/2" openings and are 6" deep. Top-stitched on the outside with an exposed top and bottom welt inside facing. The left pocket shall have a tab to button. The back pockets shall have triangle bar-tacks at the end of the openings.

**Waistband:** The trousers should be made with a 2" wide expandable waistband for exact fit with enhanced comfort and mobility. The waistband on the front panel has an extension that joins to the inside of the back waistband with heavy-duty hidden elastic. This construction enables the waistband to automatically expand and contract 2 to 4 inches. It should be stabilized with fusible non-woven interlining. The waistband shall

close with two crush proof hooks and eyes, which are reinforced with canvas stays. There shall be a bar-tack behind each eye. The stretch waistband curtain finishes 2 5/8" wide. The upper portion is made of 1 1/8" wide bias cut pocketing fabric with 1/16" topstitching and 3/4" wide stretch Ban-Rol or equal to canvas. The lower portion is 1 1/2" wide and is made of woven elastic with 3-strand Mini Snugtex or equal to, to insure shirt tail "tuck". A straight bar-tack shall be stitched at the bottom of the fly from the outside of the garment, through the zipper tape, the right and left fly and the right fly lining. The right and left fly shall be joined by an additional bar-tack located below the bottom zipper stop on the inside of the trousers. The zipper and fly topstitching extend to the top of the waistband.

**Inside Trim:** The right fly lining extension is stitched to the front seat seam allowances and extends to the inseam.

#### **Diamond Gusset:**

All trousers must have a one-piece diamond gusseted crotch construction for enhanced comfort, mobility and wear life. All edges must be serged prior to setting the gusset. After the gusset is set, it is topstitched, 1/16" from the edges.

Creasing: The front and rear creases in the trouser legs incorporate a permanent modified silicone crease produced by the CREASET®® system or equal to, that is specially formulated for fabrics with high technology treatments.

**Stitching:** The entire trouser is to be stitched with matching polyester core or 100% polyester spun thread. The thread shall be colorfast and match the fabric. All visible stitching must be 10-11 stitches per inch. All exposed inside seams are to be serged. The seat seam must be stitched with a tandem needle machine. There is a minimum 2 3/4" seat outlet for alterations.

LABELING: Trousers shall be labeled with the following information: manufacturer, style number, size, fiber content, and care instructions.

**Sizes:** The trousers shall be hemmed and be available in a regular rise length in waist sizes 28 through 60. Odd waist sizes are to be available through 37. Ladies trousers should be available in sizes 2 - 24 with regular rise length.

**Pockets:** Two patch pockets with 1 3/8" stitched box pleats and mitered corners. The pockets are to be die cut and finished 5 1/2" wide and 6" long. Left pocket to have a sewn through pencil stall 1 1/2" wide. Velcro hook fasteners 3/4" wide and 3/4" long are stitched on the upper corners to secure the Velcro loop fasteners on the flaps. Velcro must be washable and durable.

**Pocket Flaps:** To be die cut, and scalloped, finishing 5 1/2" in width, 2 1/2" in length at the center and 2 1/8" at each side. Flaps are interlined with 250 denier Dacron Polyester, topstitched 1/4" from edges and have one centered uncut buttonhole with button. Flaps to be set with a 1/4" space between pocket and flap. The left flap to have a hidden pencil opening 1 3/8" in width, bar-tacked at each end. **Design:** Shall feature the Perfection EGC System™ Design or equal for enhanced comfort and mobility. Plain front, coat style with banded collar and placket front. Gusseted fit, designed to accommodate body armor, with enhanced comfort & mobility. Long sleeves with rounded barrel cuffs. 1-piece sleeve and EGC side gussets. Two pleated breast pockets with scalloped flaps and Velcro® or equal closures. Bartacked hidden pencil opening. Shoulder straps. Interior badge sling. Collar and Band: The long sleeve Class "A" uniform shirt shall be designed for use with a clip on neck tie. Collar and neck band are to be die cut. The top buttonhole is horizontal and 5/8" below the neck seam. The remaining buttonholes are vertical, with 2 1/2"spacing between the first and second and 3 1/2" spacing between the remainder. Melamine buttons (to include a spare) are stitched to the right front. Each front is to have an approximate 3" turn back. One military crease in each front incorporates a permanent CREASET® Super Silicone crease that continues through the pocket and pocket flap.

**Shoulder Straps:** Shoulder straps are to be die cut and interlined with 250 denier Dacron Polyester. Shoulder strap is topstitched 1/4" from the edge and has a buttonhole. To be sewn into sleeve head seam and measure 2 1/8" wide, tapering to 1 5/8" at the pointed end. Shoulder strap to be set approximately 1/2" from the neck seam, with the lower edge 1/2" below the shoulder joining seam. It shall be X-stitched to shoulder, 2" from sleeve seam, and shall fasten to the shoulder with a melamine button.

**Badge Reinforcement:** 2-ply inside sling approximately 1" wide, extending from shoulder joining seam into pocket of left front. To have two small uncut horizontal buttonholes 1 1/2" above the pocket flap, spaced 1 5/16" apart and centered on the sling.

**Pockets:** Two patch pockets with 1 1/2" stitched box pleats and mitered corners. The pockets are to be die cut and finish 5 1/2" wide and 6" long. Left pocket to have a sewn through pencil stall 1 1/2" wide. Velcro® or equal hook fasteners 3/4" wide and 3/4" long are

stitched on the upper corners to secure the Velcro® or equal loop fasteners on the flaps.

**Pocket Flaps:** To be die cut, and scalloped, finishing 5 3/4" in width, 2 1/2" in length at the center and 2 1/8" at each side. Flaps are interlined with 250 denier Dacron Polyester, topstitched 1/4" from edges and have one centered uncut buttonhole with button. Flaps to be set with a 1/4" space between pocket and flap. The left flap to have a hidden pencil opening 1 3/8" in width, bartacked at each end. Velcro® or equal loop fasteners 3/4" wide and 3/4" long are stitched on the underside of the flaps to secure the Velcro® hook fasteners on the pockets.

**Sleeves:** The sleeves have 1" hems. The sleeves are hemmed after the side-joining operation. A size 16 will finish 10" long from the shoulder seam.

Side Gussets: Perfection EGC System™ or equal incorporates side gussets for enhanced comfort and mobility. The gusset is a 1-piece self fabric piece that extends from the sleeve opening to the shirt hem. The graduated gusset measures 4" at each end and widens in the armhole area. The EGC Gusset is set with double needle stitching for enhanced performance.

Back: Two piece yoke lined on the inside with 65% polyester/35% cotton poplin. Yoke shall measure approximately 3" at center back and 3 1/4" at the ends. 1/16" topstitch on lower edge. The three military creases in the back of the shirt must incorporate permanent Super Silicone creases, utilizing the CREASET® System or equal.

Buttons: To be a 20-ligne melamine button to match the fabric color.

**Stitching:** The entire shirt is to be stitched with 100% polyester core/100% polyester wrap thread. All visible stitching must be 10-12 stitches per inch. Sleeve setting shall be done with an over edge and safety stitch. The gusset is set with double needle stitching. The outer edges of the collar are topstitched 3/16". The center front pleat has 2 rows of stitching 1" apart. The shoulder straps and pocket flaps are topstitched 1/4"from the edges. There is a second row of topstitching 1/4" from the flap setting stitches. The lower edge of the yoke is topstitched 1/16".

**Military Creases:** One military crease in each front must incorporate a permanent modified "Super Silicone" crease produced by the CREASET® System or equal that is specially formulated for fabrics with high technology treatments and continuing through the pocket and pocket flap. There are three military creases in the back of the shirt with CREASET® permanent silicone creases.

**Construction:** The collar, pocket flaps and shoulder straps are made by the conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally topstitched.

Shirt Labeling: The shirt shall be labeled with the following information: Make/Model or Series, size, fiber content, care instructions, RN number and country of origin

**Finishes:** Nano/H2Tech Finish: Pre-cured, wrinkle resistance, superior color retention, and external hydrophobic resistance to most water and oil based liquids. (Other surface treatments are unacceptable.)

**Design:** Shall feature the Perfection EGC System™ Design or equal for enhanced comfort and mobility. Short sleeve shirt style with convertible collar and placket front. Gusseted fit, designed to accommodate body armor, with enhanced comfort & mobility. 1-piece sleeve and EGC side gussets. Two pleated breast pockets with scalloped flaps and Velcro® closures. Collar: The Women's short sleeve Class "A" uniform shirt shall be designed to be worn primarily with an open collar. The shirt has a convertible collar. One military crease in each front incorporates a permanent CREASET® Super Silicone or equal crease that continues through the pocket and pocket flap.

Shoulder Straps: Shoulder straps are to be die cut and interlined with 250 denier Dacron Polyester. Shoulder strap is topstitched 1/4" from the edge and has a buttonhole. To be sewn into sleeve head seam and measure 2" wide, tapering to 1 5/8" at the pointed end. Pocket Flaps: To be die cut, and scalloped, finishing 5 1/2" in width, 2 1/2" in length at the center and 2 1/8" at each side. Flaps are interlined with 250 denier Dacron Polyester, topstitched 1/4" from edges and have one centered uncut buttonhole with button. Flaps to be set with a 1/4" space between pocket and flap. Weight: 6.25 - 6.50 oz/square yard

Construction: 86 warp x 52 filling

Tensile Strength: 195 x 80 lbs.

Finishes: Pre-cured, wrinkle resistant and H2 Tech treatments to provide superior color retention, internal hydrophilic wick-ability and breath-ability, and external hydrophobic resistance to water based liquids (Other surface treatments are unacceptable.)

UV/Sun Protection - UPF 40 + rating

**Design:** Plain front, coat style with convertible collar and square bottom. Covered placket with zip closure. Long- sleeves with squared barrel cuffs. One-piece sleeve and side gussets. Two breast pockets with flaps and Velcro closures. Bar-tacked hidden pencil openings. Shoulder straps. Interior badge sling. Five CREASET® or equal silicone military creases. Graduated tail lengths. Stabilized wing epaulets with reinforced microphone holder in each epaulet. Velcro is durable and washable.

**Collar:** The shirt has a convertible collar. The collar is to be die cut, measure 3 1/4" long at the points and be topstitched 1/4" from the edge. It shall be interlined with 250 denier Dacron Polyester. Permanent mylar collar stays are set forward, and inside the collar with no stitches showing through either ply.

Front: The left front is to have a covered placket with a 14" zipper. There is a buttonhole above the zipper and a buttonhole below the zipper. Both buttonholes are inside the placket and are not visible on the outside of the shirt. Melamine buttons (to include a spare) are stitched to the right front. Each front is to have an approximate 3' turn back.

**Epaulets:** the epaulet is  $1 \frac{3}{4}$ " wide at the neck seam and widens to  $7 \frac{1}{4}$ " at the sleeve head seam.

**Pockets:** Two patch pockets with 1" inverted pleats and mitered corners. The pleats have horizontal bartacks at each end of the 3 ½" openings. The pockets finish 5 1. /2" wide and 6" long. Both pockets to have a sewn through pencil stall 1 1/2" wide. Velcro hook fasteners 1" wide and 1' long are stitched in the upper corners to secure the Velcro loop fasteners on the flaps. The Velcro hook fasteners are box stitched and X stitched. The pockets are set at 45 degree angles for easy access.

Pocket Flaps: The pocket flaps are rectangular, finishing 5 3/4' wide and 2 1/4" long. Flaps are interlined with 250 denier Dacron Polyester, topstitched 1/4" from edges. **Sleeves:** The sleeves have a pleat and 4 1/2" vent openings, with a  $\frac{1}{2}$ " continuous facing secured with a bartack at the upper end

Cuffs: Cuffs have square corners and are interlined with 250 denier Dacron Polyester. Cuffs to close with 1 button hole, and 2-button adjustment option, be 2  $\frac{1}{2}$ " wide and have  $\frac{1}{4}$ " topstitching.

**Side Gussets:** The gusset is a 1-piece self fabric piece that extends from the cuff to the shirt hem. The graduated gusset measures 4" at each end and widens in the armhole area. Gusset is set with double needle stitching.

Back: The back is of one piece construction.

Buttons: To be a 20-ligne melamine button to match the fabric color.

**Stitching:** The entire shirt is to be stitched with 100% polyester wrap thread. All visible stitching must be 10-12 stitches per inch. Sleeve setting shall be done with an over edge and safety stitch. The gusset is set with double needle stitching. The outer edges of the collar, pocket flaps and cuffs are topstitched 1/4". The center front pleat has 2 rows of stitching 1" apart. The shoulder straps are double needle topstitched. Second row of topstitching 1/4" from the flap setting and cuff closing stitches. The bottom is finished with a 1" hem.

Welt/Collar Knit: Rib Knit with raised parallel corded rib trim design.

Finish: Permanent hydrophilic/wickable finish with Microban antimicrobial treatment for continuous odor control for the lifetime of this garment by inhibiting the growth of bacteria, mold and mildew that cause stains and odors.

**Design:** Design is for enhanced comfort and mobility. Short sleeve shirt style with full fashioned knit collar and 3-button placket front. One-piece design and side gussets for enhanced fit, comfort, and mobility. Banded sleeve to match collar.

Collar: The shirt shall feature a 3" full fashioned rib knit collar with parallel corded rib trim design for enhanced collar smoothness, matching sleeve. The rib-knit collar shall be dyed to match the shirt fabric. The neck seam shall be covered with matching fabric.

The sleeves have a 1" band finish with parallel corded rib trim design, matching collar and pocket detail. A size L finishes 9 3/4" long from the shoulder seam. The left sleeve is to have a pen pocket.

**Side Gussets:** Gussets are incorporated for enhanced fit, comfort and mobility. The gusset is a 1-piece self fabric piece that extends from the sleeve opening to the shirt hem. The graduated gusset measures 4" at each end and widens in the armhole area. The gusset seams are finished with double needle stitching for enhanced performance.

Back: The back of the shirt has a 3 1/2" deep circular facing.

**Buttons:** To be a 20-ligne melamine button to a match the fabric color.

**Stitching:** The entire shirt is to be stitched with 100% polyester core/100% polyester wrap thread. All visible stitching must be 10-12 stitches per inch. Sleeve setting and gusset setting shall be done with an over edge and safety stitch and finished with double-needle topstitching. The epaulets are topstitched 1/4" from the edges.

Embroidery: Varies by agency. Specifications for each are included

Labeling: The shirt shall be labeled with style number, size, fiber content, and care instructions.

Sizes: Unisex shirts should be available in alpha sizes from Small to 5 XL.

# 13. Tactical Response Combat Shirt

Fabric: The shirt's torso is constructed of highly breathable no melt no drip CORDURA® Baselayer or equal fabric, a 60/40 cotton nylon blend with advanced moisture management capabilities that also reduces the severity of burn injuries. The

fabric wicks moisture away from the skin and dries rapidly, preventing the fabric from sticking to the user's skin and greatly increasing comfort. The sleeves and upper back panels of the shirt are constructed of a lightweight, but durable and abrasion-resistant 50/50 Nylon /Cotton or 65/35 Polyester/Cotton Rip-stop fabric designed to provide extra protection for areas not protected by body armor.

**Color:** It is our intent to primarily purchase the color combinations of Olive Drab Body/Olive Drab Sleeves and Navy Blue Body/Navy Blue Sleeves. However, the vendor shall make all body/sleeve color combinations available under the terms of this contract and shall list all such color combinations in their bid response.

Fiber Content: torso (body) no melt no drip CORDURA® Baselayer or equal fabric, a 60/40 cotton nylon blend. Sleeves/Upper Back panels: a lightweight, but durable and abrasion-resistant 50/50 Nylon /Cotton or 65/35 Polyester/Cotton Rip-stop fabric designed to provide extra protection for areas not protected by body armor.

General Design & Description: The TRU-SPEC® or equal Combat Shirt is a stand alone shirt intended to greatly increase user comfort through the use of lightweight, moisture-wicking, and breathable fabrics. The shirt's torso is constructed of highly breathable no melt no drip CORDURA® Baselayer fabric or equal, a 60/40 cotton nylon blend with advanced moisture management capabilities that also reduces the severity of burn injuries. The fabric wicks moisture away from the skin and dries rapidly, preventing the fabric from sticking to the user's skin and greatly increasing comfort. The sleeves and upper back panels of the shirt are constructed of a lightweight, but durable and abrasion-resistant 50/50 Nylon /Cotton or 65/35 Polyester/Cotton Rip-stop fabric designed to provide extra protection for areas not protected by body armor. Each sleeve has an anti abrasion padded elbow patch. No-seam shoulders minimize rubbing or chafing against armor. Other features include zippered storage pockets on the upper arm, and a place to attach name, rank, and flag on the upper arm.

**Stitching:** Seam specification is 10 - 12 stitches per inch (SPI) on; lock stitch, chain stitch, safety and serge seams, Bar-tacks - 36-42 SPI. Seam allowances - Serge machine 3/16" - 1/4", Safety Stitch machine 3/8" - 1/2", all edge stitching that requires folded under fabric is 1/8" - 1/4".

**Collars:** The collar is a turtle neck of rib knit. The finished measurement is 1-3/4" high. The collar is set with a 4-thread serge machine with topstitch in the back of the collar.

**Sleeves:** The sleeves are raglan with upper zippered storage pockets and anti abrasion foam elbow pads. The cuff has a tab with hook and loop closure. The cuff will be hemmed with a 1 -1/2" clean finish single needle hem. Each cuff will have a pointed tab with finished measurements of 4-1/4" long by 1 1/2" wide. The tab will be set with a box stitch. It shall have a 1" by 1-3/4" hook attached below the point. The cuff shall have a 1" by 6-1/2" loop attached at the hem. Each sleeve has a 6" underarm gusset for increased movement and comfort.

**Elbow Patch:** Each sleeve will have an anti abrasion padded elbow patch. The patch shall be oval shaped, 8 1/2" by 10" with binding on the perimeter. It shall be stitched with cross and x stitching. It shall be centered 11 1/2" from the sleeve hem.

Sleeve Pockets: Both sleeves will have upper zippered storage pockets. The pocket will be bellowed to the rear with a welt type construction for the opening. The pockets will have vertical zipper closure with the opening 1" from the front edge of the pocket. The finished measurements of the pockets will be 8 -1/2" high by 7" wide. The left sleeve pocket will have 4" by 6" loop patch attached to the outside 1 ½" from the top of the pocket and centered. The loop shall be stitched on all sides and have a stitch centered lengthwise. There shall be a 4 1/2" by 1" pointed tab attached even with the top of the loop patch. It shall have a 1" by 1-1/4" piece of hook attached below the point of the tab. The right sleeve pocket will have 4" by 6" loop patch attached to the outside 1 ½" from the top of the pocket and centered. The loop shall be stitched on all sides and have a stitch centered lengthwise.

**Back Panel:** The back panel will measure 11-1/2" from the neck at center back and will be clean finished at the bottom with a 1/8" edge stitch.

Side / Sleeve Seams: Side seams are closed with a serge stitch. Sleeves are set with a serge stitch and 1/4" topstitched.

Hem Bottom: The hem measures 1" with a cover stitch closure.

Labeling: The garment will have heat transfer labels with the manufacturers' country of origin, size, fiber content, and care instructions.

Sizes: Shall be available in Men's Sizes (chest) Small (40) through 2XL (56), inclusive with sleeve lengths starting at 31  $\frac{1}{4}$ " through 33  $\frac{1}{4}$ ", in one inch graduated increments commensurate with chest size.

#### 14. Raincoat, full length, reversible

**General:** SPIEWAK & SONS, INC. Style S309V or equal. The raincoat shall be full-length, single layer, reversible, and waterproof. The reverse high visibility side shall meet or exceed the requirements for ANSI 107-2004, Class 3. The raincoat shall have a triple fly front with a snap closure and side access pockets. Double needle construction shall be used throughout and all seams shall be taped to prevent leakage.

Material: The shell fabric shall be single layer, 100% Nylon Oxford, with a permanent polyurethane pigment coating. The shell fabric shall have a durable water repellent finish with a minimum spray rating of 90. The reverse side pigment coating shall meet the requirements for certification to the ANSI 107-2004 and EN 471 standards. Independent third party certification must be provided upon request that the fluorescent fabric side and retro-reflective trim meet all the requirements listed in Section 6 of the ANSI 107-2004 standard.

Body Detail: The front shall have two large welt access pass through for access to equipment. There shall be a badge on the left breast of the shell surface side and on the left breast of the hi-viz side to hold a badge. There shall be a badge tab made of self

fabric with two black oxidized metal eyelets located 1 1/2" apart on the left chest of both sides of the shell fabric of the garment to attach a badge. The badge tabs shall be located 9" down from the high point of the shoulder.

There shall be a 2 1/2" wide facing on the right hand shell surface side, that shall attach with /24 metal oxidized snaps to a 3" inside fly and a 3" outside fly to insure water tight integrity. The 6 snaps on each side shall be spaced 3 ½" apart and reinforced with urethane rings for reinforcement. The coat shall measure approximately 48" long (size L) from the neckline to the bottom of the coat

There shall be a 5/8" turn up around the entire bottom sweep of the raincoat. There shall be a black collar formed by two pieces of shell material approximately 4" wide at center back with 4" collar points.

Pockets: The access side openings shall be finished with a 9 ½" by 1 ¾" two-ply welt of self-material.
