# Wildlife Management Areas Purchase of No-Till Seed Drills

The West Virginia Purchasing Division for the West Virginia Division of Natural Resources is requesting bids for the purchase of two (2) No-Till Seed Drills. All items are to be F.O.B. Destination. Freight or delivery charges must be included in the price of the goods. Delivery must be made within thirty (30) days of purchase order award. The award may be split if it is in the best interest of the West Virginia Division of Natural Resources.

## **General Specifications:**

Seed Drills must be manufactured for commercial use. All items must be new (2011 model)

### Information for Bidders:

Bidders must submit a unit price bid for each item to furnish all items specified.

## **Damaged Items:**

Damaged or defective items must be replaced at no additional expense to The West Virginia Division of Natural Resources.

## Warranty:

The equipment must be guaranteed to be free of defects in workmanship and material for a minimum of one (1) year from date of acceptance. However, if manufacturer warranty periods are longer than the required minimum one year warranty, those warranties shall apply.

#### No-Till Seed Drill

Great Plains Model 706NT No-Till Seed Drill or equal. Drill must meet the following specifications:

- Must have a minimum planting width of seven (7) ft, with a minimum of ten (10) rows;
- Must have a primary seed box capacity of 2.5 bushels per ft or greater.;
- Must have a small seed (legume) box for plants with small seeds (i.e. clover, alfalfa, switch grass)
   and a large grain seed box for plants with large seeds (i.e. wheat, soybeans, peas);
- Must have adjustable row spacing;
- Must have a warm season grass seed box;

- Must have an acre meter;
- Must have transport lights;
- Must have weight brackets;
- Must have water tight seed box lids;
- Must have lock out hubs and a minimum 8 ply highway compatible tire;
- Must have a folding hitch.
- Must have rear walk board for loading seed.

# **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compliance with the requirements as stated.
