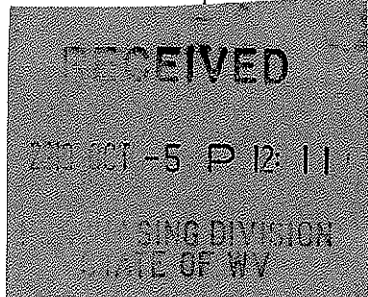

An award shall be made for each Vehicle Class to the lowest, responsible bidder meeting specifications using the base price of the vehicle bid, including delivery cost and life-cycle costing, pursuant to the changes in the West Virginia Code. The life-cycle costing to be used shall be the gasoline consumption for 100,000 miles. This will only apply to vehicles < 8,500 GVWR.

Gasoline Costing Information:

100,000 ÷ MPG Average (25% - City – 75% Highway)
Gasoline shall be based on \$3.00 per gallon.



