REQUEST FOR QUOTE

The West Virginia Purchasing Division, for the West Virginia State Rail Authority (SRA), is soliciting bids for the purchase of a Low Profile Portable Wheel Lathe.

DESCRIPTION

Low Profile CNC Portable Wheel Lathe. (with all standard equipment for operation)

- Lathe is to be CNC Controlled for an accurate profile
- This lathe should be operational without the need for an operator to be under the locomotive during operation
- Wheels must be able to be profiled while still on the locomotive
- Lathe should be able to set up and run the opposite wheel without dismantling the lathe
- Lathe should turn wheels symmetrical within FRA tolerances

Additional Items:

TRAINING

Lump sum price is to include an all inclusive price (onsite labor and all travel costs) for two (8 hour days) of training onsite by one trainer. Training should include:

- Attachment and Lathe set up
- Lathe Operation
- Maintenance and trouble shooting

Successful vendor will provide information to the SRA prior to the trainer's arrival describing how the locomotive should be prepared for a demonstration. Per the vendor's instructions, the SRA will have the brake rigging removed and a unit ready to be turned when the trainer arrives.

WARRANTY

Lathe must come with a warranty that states machine is free of manufacturing defects for a period of one (1) year. This warranty is to include all parts and labor necessary to correct any manufacturing defects.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compliance with the requirements as stated.
