

"All qualified Vendors who submit a valid bid for "FOB Division's Storage Site", Section 12, Bid Schedule will be awarded a contract for those locations for which their bid is low.

Response: The term "locations" should read "county locations".

5. "Are the 0 tons for the locations listed on the bid schedule page for pricing, considered place holders?"

Response: Please refer to Section 2. Scope of Work, from the Bid Specifications. Even though the Division of Highways does not list an estimated quantity to be delivered to some county locations, we do not want to remove these county locations in case of a need for Road Salt at that county location. If the need should arise, an Agency Release will be issued by the Division of Highways to the awarded vendor. Quantities listed on the Bid Schedule are estimates.




