GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 12. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 13. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, is available online at www.state.wv.us/admin/purchase/vrc/hipaa.htm and is hereby made part of the agreement. Provided that the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.
- 14. CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in http://www.state.wv.us/admin/purchase/privacy/noticeConfidentiality.pdf.
- 15. LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, and the West Virginia Insurance Commission. The vendor must provide all necessary releases to obtain information to enable the director or spending unit to verify that the vendor is licensed and in good standing with the above entities.
- 16. ANTITRUST: In submitting a bid to any agency for the State of West Virginia, the bidder offers and agrees that if the bid is accepted the bidder will convey, sell, assign or transfer to the State of West Virginia all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of West Virginia for price fixing and/or unreasonable restraints of trade relating to the particular commodities or services purchased or acquired by the State of West Virginia. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to the bidder.

- 4. All quotations must be delivered by the bidder to the office listed below prior to the date and time of the bid opening. SRIC SNOWPLOWS – PICKUP TRUCK PLOW WITH OPTIONS OF 7 ½ FOOT, 8 FOOT, OR 8 ½ FOOT PLOW

1.0 PURPOSE

It is the purpose of these specifications to describe a 7 ½ Foot, 8 Foot, or 8 ½ Foot Plow (hereinafter referred to as a "plow" or a "unit") to be purchased for use by the West Virginia Division of Highways (DOH) on an Open End Contract basis.

2.0 BIDDING PROCEDURES

The current purchasing procedures regarding bidding as established by the Department of Administration, Purchasing Division, shall apply. Failure to submit the "Request for Quotation" forms, complete in its entirety and according to directions indicated, may subject the bidder to disqualification. Each bid submitted shall also be accompanied by a Bidder's Evaluation Report completed in detail. Addendums in order, along with exception sheets, should be with Bidder's Evaluation Report. FAILURE TO SUBMIT THE BIDDER'S EVALUATION REPORT, COMPLETE IN ITS ENTIRETY, WILL RESULT IN AUTOMATIC DISQUALIFICATION.

3.0 SPECIFICATIONS

The specifications named herein, mandatory and non-mandatory, establish the acceptable level of quality only and are not intended to reflect a preference or favor any particular brand or vendor.

3.1 EXCEPTIONS TO NON-MANDATORY SPECIFICATIONS

Exception to a non-mandatory unit specification may be made by the bidder, providing the exception is not available from the manufacturer. Any such exception must be noted on the bidder's evaluation report and should be accompanied by supporting documentation/literature from the manufacturer. Any exception must be indicated on a separate attachment to the bidder's evaluation report and labeled as "Exception to Specifications". The state reserves the right to waive minor irregularities in bids or specifications in accordance with §148-1-4(f) of the WV Legislative Rules and Regulations.

3.2 MANDATORY SPECIFICATIONS

All specifications preceded by "shall, will, and/or must" or are stated as a "minimum and/or maximum" are mandatory as stated in Purchasing Divisions Policies and Procedures. Any bid failing to meet any mandatory item shall be immediately disqualified. Failure to respond in the appropriate evaluation section will also be grounds for immediate disqualification at the discretion of the State.

A mandatory pre-bid conference is scheduled for this equipment purchase as stated in the RFQ. Vendors having products with variations or exceptions in specified mandatory items are expected to address any such variations or exceptions during the pre-bid conference. The State shall review and consider any such variation or exception, and may at its sole discretion, issue an addendum to change mandatory specifications deemed to be in the State's best interest. Bids from any vendor failing to attend the mandatory pre-bid shall be disqualified. Bids containing any variation or exception to a mandatory specification that was not addressed during the pre-bid conference and accepted by the issuance of an Addendum shall be disqualified.

4.0 REPRESENTATIVE UNIT FOR TEST

The successful vendor must (if specified) provide DOH one (1) completed representative unit to be observed and evaluated on each order to insure compliance with specification. If requested, the time period for testing and evaluation shall be seven (7) working days following receipt of the unit. DOH will incur no obligation for deterioration of surfaces, finishes, seals, and mechanical or electrical parts on the unit resulting from operation and testing within the limits of these specifications; nor will DOH incur obligation for damage to the unit resulting from failure to meet specifications when due care and attention is given by DOH and testing is done within the limits of these specifications. Failure of the pilot unit to satisfactorily meet specifications as bid may be cause for cancellation of the purchase order, and return of the delivered unit along with all associated equipment to the vendor at the vendor's expense.

4.1 CONDITION OF UNIT(S) UPON DELIVERY

All units must arrive at the prescribed delivery point having been completely preserviced with oil, lubricants, and coolant. All prescribed precautions pertaining to first operations and break-in of the unit are to be posted conspicuously on the unit for ready observance by the operator.

4.2 DELIVERY

Delivery is an integral part of this specification and failure to comply will be cause to initiate a D.O.T. Administrative Form WV-82, Vendor Performance Form. The WV-82 Form will provide a means of officially notifying the Purchasing Division and the vendor of unsatisfactory performance; such as late deliveries, poor service, inadequate parts supplies, etc.

The decision to initiate subject Form will be at the sole discretion of the D.O.H. Commissioner's established Equipment Review Board.

Issuance of the WV-82 Vendor Complaint Form on unsatisfactory delivery against any vendor will be cause to refuse to consider similar items from those vendors on future Request For Quotations.

(NOTE: Delivery time could be altered due to labor strikes, severe inclement weather conditions, etc.)

- 5.0 AWARD CRITERIA
- DOH will recommend the award in accordance with the RFQ evaluation criteria described in the requisition. The award shall be made to the lowest unit cost vendor that meets or exceeds the specifications. DOH reserves the right to place multiple orders in any quantity.
- 6.0 SPECIFICATIONS AND GUIDELINES GENERAL
- 6.1 IDENTIFICATION OF THE UNIT BEING PROPOSED

The bidder must identify the unit by manufacturer, model, series, and year of manufacture, to enable identification by DOH in the manufacturer's specifications of the proposed unit. The bidder will submit complete descriptive literature of the proposed unit, to establish that the bid is the manufacturer's most current model, including latest engineering improvements, which have been, or will imminently be, regularly advertised and sold on the open market. The unit specified herein and offered

to be manufactured after January 1, 2011 and be clearly identified and marked with date of manufacture.

6.2 OPERATING AND SERVICE MANUALS AND PARTS LISTS

An operator's manual must be included with each unit upon delivery. 6.4 PREVENTIVE MAINTENANCE AND OPERATOR PROCEDURES:

# SECTION 1 POLICY & PROCEDURES

The following information describes the warranty policy and procedures that must be followed for processing all warranty claims pertaining to WESTERN® snowplows and ice control equipment. This policy is extended only to authorized WESTERN distributors. Western Products reserves the right at any time to change any or all of the policy and procedures or the labor rates. These changes become effective immediately and will supersede any previous notices regarding policy.

#### 1.1 Warranty Coverage

Snowplows and Ice Control Equipment

Western Products warrants each WESTERN snowplow or ice control equipment for a period of two (2) years after the date of purchase by the original user, to be free from defects in material and workmanship. Western Products warrants Suburbanite™ snowplows, accessories, service parts and components purchased separately for a period of one (1) year after the date of purchase by the original user, to be free from defects in material and workmanship. The warranty period of a service part that replaced an original part under warranty, will be limited to the remainder of the original part warranty.

To obtain coverage under warranty, the product must be returned to an authorized WESTERN distributor. (See Sections 1.4–1.7.) Those parts may be requested to be returned to Western Products.

If within the warranty periods any part is proven to Western Products' satisfaction to be defective, that part will be repaired, replaced, or credited to the distributor by Western Products, or repaired or replaced for the owner by its distributor. (See Appendixes B, C, D and E for WESTERN Commercial/ Consumer Limited Warranty Sheets.)

The owner of the product must present their proof of purchase to a WESTERN distributor to verify the purchase date.

#### 1.2 Warranty Limitations

The foregoing warranty has limitations and shall not apply to the following:

- A. Repair of parts that are not furnished or approved by Western Products or damage caused by use of such parts.
- B. Parts/components that are transferred from one vehicle to another.
- C. Unauthorized alterations and modifications to the equipment that would cause product failure.
- D. Failures resulting from user subjecting equipment to conditions other than normal use or service.
- E. Failures resulting from operations other than described in the Owner's Manual.
- F. Repairs resulting from improperly installing, servicing, or modifying components, or from not complying with WESTERN Installation Instructions and procedures, Mechanic's Guide, Service Bulletins, or any other literature pertaining to servicing the product.
- G. Standard product maintenance such as but not limited to:
  - retightening fasteners
  - refilling fluids
  - periodical adjustments
  - cleaning/tightening/greasing electrical connections
  - lubrication of pivot points
  - repairs to finish
  - etc.
- H. Wear item parts replaced due to the normal operating conditions such as but not limited to:
  - disc shoes
  - cutting edges
  - base angle
  - blade guides
  - pins
- Parts replaced due to corrosion or contamination caused by improper maintenance or storage of equipment.
- Damaged finish due to shipping, handling, storage and/or wear due to use.

- Repairs or parts replaced due to incorrectly troubleshooting the initial damage.
- Repairs performed on the product by other than the distributor (except as noted in Distributor Responsibility, Section 1.5, Paragraph C).
- M. Repairs or damage not resulting from defective material and/or workmanship.
- N. Repairs or damage to motor vehicle and/or frame of vehicle as a result of installing snowplow or ice control equipment to the vehicle.
- Indirect cost incurred by user while WESTERN® equipment is being repaired during warranty period such as but not limited to:
  - lost time
  - miscellaneous charges not directly related to the product defect
  - equipment rental
  - transportation charges
  - etc.
- P. Spreader engine warranty is covered by its manufacturer's warranty.

#### L3 Labor

- A. abor credit allowance is available to the distributor for each part determined by Western Products to be warrantable. The allowance is based on the established distributor shop labor rate documented at Western Products, and computed in accordance with the current labor flat rate times.
- B. Distributor labor rates indicating the current shop labor rate must be reported to Western Products on Labor Rate Update Forms. (See Appendix A.) Distributors may have one update to their shop labor rate at any time during a calendar year.
- C. All claims subpatted prior to the request for a shop labor rate update will be processed at the older labor rate.
- Parts visually defective at installation are not covered by labor warranty.
- E. Labor allowance for the replacement of parts will be credited only to parts proven, to Western Products' satisfaction, to be defective.

- F. A warranty claim for labor only must include a copy of the repair order, proof of purchase and a completed warranty claim form. The proof of purchase must include the complete serial number(s), as applicable.
- G. Approval of labor allowance is determined by the WESTERN Technical Service Department. This department reserves the right to reject any labor claims that do not conform with the warranty policy and procedures set forth in this manual.
- H. No labor credit is given if repair or part replacement is performed by the end-user.
- Repair vs. Replacement The outlet is expected choose the most cost-effective procedure in making epairs. Western Products reserves the right to limit the labor allowance for the repair of a part of exceeds the replacement cost of the part.
- J. Labor times shall not be stacked when a repair equires the removal of a number of parts.

#### 1.4 Returned Parts

All parts returned to Western Products for warranty evaluation are to be sent prepaid with a completed Warranty / Product Return Form and Proof of Purchase for product sold to an end user. Pictures, in place of hard goods, are acceptable only when authorized by the WESTERN Technical Service Department. Photos may be mailed to Western Products, Attention Tech. Service. Digital pictures may be e-mailed to tech@westernplows.com.

Parts that are photographed plust be retained by outlet until disposal of parts is authorized by Western Products.

- B. Credit for faulty parts will be issued to the outlet at net price if Western Products determines parts are faulty. However all warranted and repairable hydraulic components, controls and tight kits will be rebuilt by Western Products and returned to the outlet prepair.
- C. Warranty approval will be determined by the WESTERN Technical Service Department. If claim is rejected, the labor allowance will also be rejected.

#### PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, Limited Liability Company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
