In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services.
 6. Interest may be paid for late payment in accordance with the **West Virginia Code**.
 7. Vendor preference will be granted upon written request in accordance with the **West Virginia Code**.

Q1: Is Firestone Building Products fully adhered .060" non reinforced roof system with 2 layers of Firestone Polyiso insulation, 6" seams, and 15 year warrantee allowed to be installed on this roofing project?

A1: Firestone Building Products is an acceptable manufacture for the roofing system. Contractor must still comply will all requirements stated in the Specifications.

Clarifications:

- C1: It is the Contractors responsibility to cover the gym floor and other areas inside the building below where the roof is currently being replaced.
- C2: The duration of this project to be 180 days after the Notice to Proceed. This was changed in the event the weather gets colder sooner in the year and the adhesive will not dry.
- C3: It is the Contractors responsibility to contact Triad to report the asbestos.
- C4: On the front section of the roof beside the gym roof, contractor to install rubber to top on the front and both side sections, address with facial and nailer. On the back section, add additional surface mounted counter flashing and seal the bricks above the rubber.
- C5: Where there is stone below coping, install 1" insulation on the sides to allow wall to be same as stone coping.
- C6: In roof areas where there is gravel, the gravel can be hauled to the Pruntytown Farm. Please coordinate with the Facility.
- C7: The main section above the gymnasium is 93 feet x 79 feet = 7347 square feet with an additional 3 feet lap on the walls. There are two (2) 4 feet x 4 feet fresh air vents that must be replaced. There are two (2) 3 inch sewer vents and four (4) 1 ½ inch drains. The 1 ½ inch drains must be replaced with 3 inch drains for better drainage. There are two (2) existing exhaust fans and must be replaced with new. The exhaust fans are on top of the fresh air vents. Attached is a sketch of the roof.
- C8: The front section measures 76 feet x 18 feet = 1368 square feet with an additional 2 ½ feet lap on the walls on all four sides.

- C9: The back section measures 24 feet x 15 feet = 360 square feet with an additional 2 feet lap on all four sides.
- C10: The back canopy is 4' x 8'. The roof will need to be replaced.
- C11: The side canopy is 89" x 39". The roof will need to be replaced.
- C12: The front canopy is 7' x 40'. The roof will need to be replaced.
- C13: Install two (2) layers of 2" Polyiso Insulation below the rubber on the roof areas. In the Specifications, it states both two (2) layers of 1-1/2" in one area and two (2) layers of 2" in a different area.
- C14: Please note, the condition of the metal decking underneath the existing roof is unknown at this time. After removing the existing rubber membrane roof, it will be the contractor's responsibility to contact the DOC if the existing metal decking is badly rusted, weak, or not suitable to install the new roof. Please include a per square footage cost to replace the metal decking in the event some will need to be replaced on the RFQ.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

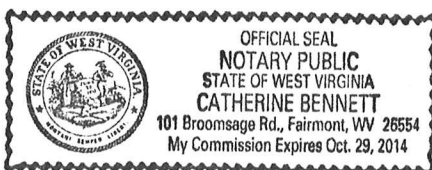

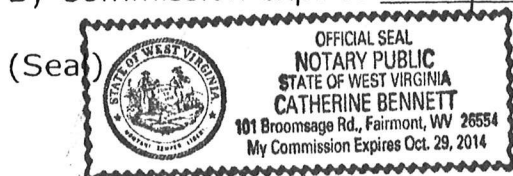
