3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.

- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.

Truck

Ford Super Duty F-Series, F-350, Crew Cab pickup, W3B, Single Rear Wheels, GVWR 11,200 pounds, Pickup Box Delete, 172.4" wheelbase, or equivalent.

Drivetrain as follows: 6.2 liter gasoline engine, 6-speed automatic transmission, 4.30:1 rear axle ratio.

The vehicle described above will be equipped with the following:

- Optional spare tire and wheel and underbody wheel carrier
- Factory tow package including hitch, plug and controller
- Upfitter switches

Other factory installed equipment would include: off road package, locking rear differential, automatic locking front hubs, power steering, power ABS brakes, air conditioning, power windows, power locks, power mirrors, AM FM with CD player, tilt steering wheel and cruise control.

**Utility Bed:** 

Knapheide 96 series 796J or equivalent

Load Tie Down System:

93" High Lift Slide N Lock Tie Down System or equivalent, installed each side of cargo area 22 inches above cargo floor.

**Utility Cabinet Lighting:** 

Rope lighting on door jamb interior, CTW part number RPL-12V-12CL or equivalent

**Tool Boxes:** 

The completed vehicle will be equipped with two tool boxes each installed on top of the curb side and street side storage cabinets of the Knapheide utility bed. The tool boxes will be sized to fit on top of the storage cabinets, which are according to Knapheide, 14.5" deep and 96" long. The height of the completed tool boxes will be 16".

The tool boxes will be constructed of 1/8" diamond plate aluminum. The tool boxes will be constructed with two doors of equal size which will be large enough to provide adequate access to the interior of the tool boxes.

The doors will be constructed with continuous hinge, which will be along the top edge of the door. When in the open position, the doors will be held in up with a gas strut mechanism. The doors will have weather tight rubber seals and stainless steel T-handle latches and lock assemblies, keyed alike. Lighting for the tool boxes will be as described for the utility bed storage cabinets.

Cab Protector:

Constructed of steel box tubing, 1.5" by 1.5". The cab protector will be fitted with mounting tabs for work lights and emergency flashing lights. The cab protector will be constructed with vertical bars of 1.5" steel box tubing on 10" centers.

Back Up Alarm:

ECCO Model 410 97db or equivalent

Lift Gate:

Thieman TT-15 or equivalent, model number TT15E4926. The lift gate will have a 12 volt DC electric over hydraulic control system. Additional lift gate requirements as follows: one piece aluminum platform, 49" wide with a 5" ramp and 26" load surface.

Rear Bumper:

Rear of utility bed will be equipped with step bumpers on each side, outboard of the lift gate. The steps will provide protection to the rear corners of the utility bed as well as provide steps for accessing the cargo area of the utility bed

Grab handles:

The rear of the utility bed will be equipped with grab handles on each side at a suitable height for accessing the cargo area of the utility bed.

Winch:

Mile Marker HI 12000 Hydraulic Winch or equivalent. The completed vehicle will be equipped with two momentary switches to operate the winch for forward and reverse operation. One momentary switch will be mounted in the passenger's compartment within easy access of the driver. A second momentary switch will be mounted on the front of the vehicle to provide operation of the winch while outside of the vehicle. The completed vehicle will also be equipped with remote switches provided by the manufacturer.

Red Emergency Light:

The emergency flashing light will be mounted to the cab protector in a way to maximize visibility and minimize overall height without being located in an area where it could be damaged by cargo or work in the cargo area.

The flood lights will be mounted as in the following description: one flood light will be mounted to the cab protector to illuminate the cargo area of the utility bed. ### **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
