1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

OPEN END AGENCY CONTRACT Televisions

The West Virginia Division of Natural Resources is requesting Bids for an open ended contract for the purchase of flat screen televisions to be utilized for upgrades and redecoration of parks in various locations. All items are to be shipped FOB Destination. Vendor shall be required to submit a Bill of Lading for all material and items shipped that clearly show actual shipping costs.

General Specifications:

All items must be new, and must be Energy Star qualified. Televisions must be flat screen, and must have the availability to be mounted securely on the wall with appropriate wall mounting systems.

Basis of Award:

This contract is split into three separate bids based upon the location of the park where these items will be initially purchased. The three locations are Blackwater Falls State Park, Davis, WV, Pipestem Resort State Park, Pipestem, WV and Tygart Lake State Park, Grafton, WV.

Vendors may bid on any or all locations.

The television package will be awarded to the lowest qualified Bidder submitting the lowest Bid for all televisions and mounting hardware at each location, as stipulated on the Bid schedule and in complete accordance with all specifications stipulated herein. Partial or conditional bids will not be considered.

Coordination:

Vendor must coordinate shipping and receiving with each park. All items must be received within thirty days of the issuance of a purchase order.

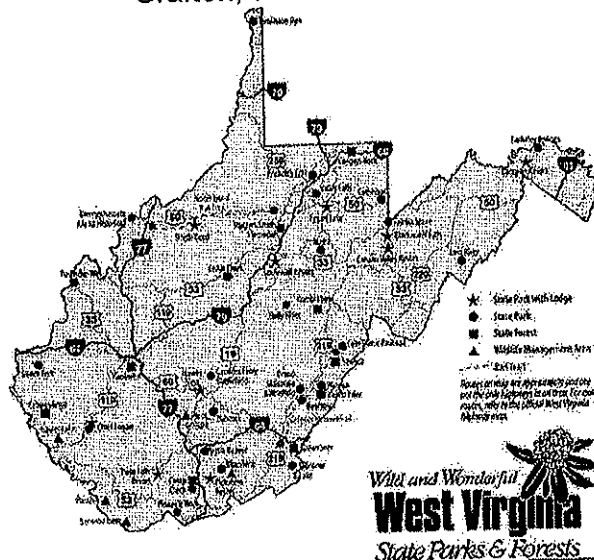
Delivery, Storage and Handling:

The successful Vendor must deliver and handle all items according to Manufacturer's recommendations, including means and methods that will prevent damage, deterioration, and loss. Goods must be delivered in the Manufacturer's original sealed containers complete with labels and instructions for handling, storage, unpacking, protecting, and installing. The Division will supply labor to inspect the goods upon delivery, to ensure compliance with the purchase order, and to ensure all items are undamaged and protected against damage. All items must be delivered according to Manufacturer's recommendations and in an order that will facilitate inspection and measurement of quantity. All items must be delivered using means and methods that will prevent damage, deterioration, theft, or other loss. All items are to be shipped FOB Destination.
