BDI Pharma is pleased to have the opportunity to participate in RFQ EHP12053. The intent of our proposal is to offer a price bid that is specific to BeneFIX RT. This is a new version of the BeneFIX product that has a new storage approval for room temperature, hence the RT acronym. The manufacturer increased their price for this newer version of BeneFIX and hence the need to rebid the contract.

I would like to clarify that BDI Pharma is currently providing West Virginia with the normal BeneFIX on the current contract. We anticipate continuing to provide the value of this lower priced product until this inventory is extinguished or the contract goes to termination. At that time it is our hope that we will win the new contract for BeneFIX RT and be able to continue supplying our services. But I state this for the reason that it is possible for another vendor to bid the old product and very well knowing that they will require switching supply over to the new cost in just the very near future. Hopefully this clarification of new NDC numbers for the BeneFIX RT will clarify that the bid evaluations are done equally:

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.
