REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
 2. The State may accept or reject in part, or in whole, any bid.
 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services.
 6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
 7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
 12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

The West Virginia Governor's Office of Economic Opportunity's (GOEO) Weatherization Assistance Program (WAP), in partnership with First Energy, is instituting the Trans-Allegheny Interstate Line Company (TrAILCO) Electric Efficiency Partnership program. This program is designed to reduce heating, cooling, and electric baseload costs for low-income families in First Energy's service territory by improving the energy efficiency of their homes. The program will provide comprehensive energy efficiency services to low-income First Energy customers in the six (6) county area, through which the TrAILCO transmission corridor passes. There are two (2) Community Action Agencies that will administer services to the six counties: North Central West Virginia Community Action Association, (Monongalia, Preston, Tucker counties) and Eastern West Virginia Community Action Agency, (Grant, Hardy, Hampshire counties). This bid is for the major appliance portion of the TRAILCO partnership.

Participation will be restricted to those low-income customers who now qualify for the U.S. Department of Energy's Weatherization Assistance Program and are customers of First Energy.

- Old appliances, qualified for replacement, are to be removed by the participating company and taken out of service and disposed of in compliance with EPA guidelines (Code of Federal Regulations). At no point will these appliances be put back into service.
- Any necessary forms will be developed by the Governor's Office of Economic Opportunity in association with the two (2) participating community action agencies and the participating company.
 - The agencies shall be able to contact the company for ordering and other purposes through at least one of the following means: toll free number, 800 number, fax number, or web based means.
 - Installation and removal must take place within 30 days after an order from the local weatherization agency is placed to the participating company. If for some reason this cannot be met due to extenuating circumstances of any particular client, the agency will be contacted and the agency and the company will make arrangements for an alternative delivery date.
- The participating company shall notify the Community Action Agency weatherization program office serving that location upon delivering and installing the specified Energy Star appliance(s) for verification purposes.
