SECTION 2: SCOPE OF WORK

AQUATECH INDUSTRIES, INC. will provide the services and testing as indicated in this section for all systems included in Attachment C, Location Schedule unless otherwise indicated.

2.1 Regular Maintenance Services:

As specified in this section we will provide the services necessary to maintain good control and reduce scale, and minimize corrosion in all systems, including control of algae, slime and other microbiological growth on other specific systems such as cooling systems.

We provide on-site expertise every time we do our monthly service calls. There may be times when an outside expert may be consulted for more details to a particular situation. If this should arise, additional charges are included as part of this contract.

2,2 Quarterly Legionella Testing:

We will provide the quarterly legionella testing as indicated in the bid proposal and the follow up report as specified. We will use a certified microbiological testing facility to run the legionella samples.

2.3 Equipment and Chemicals

The Contractor shall furnish the following information prior to the award of contract:

Detailed list of the equipment to be used and method of delivery into the various systems.

According to our discussion with the maintenance personnel, all the existing equipment will be continued in use. We are not completely sure whether this is by default of equipment by previous contractors or purchased equipment by the State of West Virginia. We intend to use all existing equipment as part of our chemical feed systems. Any chemical feed pumps that need to be replaced will be part of this contract. We use Walchem chemical feed pumps and will supply specific information as needed.

All closed loop heating and cooling systems are chemically fed by use of shot feeders (by-pass feeders). Also according to your building maintenance personnel this equipment is the property of the State of West Virginia and will be used for our feeding requirements. All the feeders are currently being used and appear reliable for our purposes.

Any of these feeders that may fail is unforeseeable and would require additional costs that cannot be calculated. If any feeders fail we would expect the State of West Virginia to negotiate necessary replacements. This expense is not to be part of this contract.

 Copies of all MSDS of chemicals/products to be utilized shall be furnished to the safety department prior to introduction of product onto the premises

If we are the successful bidder for this project we will provide all necessary MSDS as required.

All discharges into the sewage system from cooling tower bleed-off, boiler blow down or system draining must meet all federal, state and local regulations. The use of molybdate is prohibited.

AQUATECH products being used for this contract do not contain any molybdate.

3.1 Closed hydronic systems, including hot water heating and chilled water closed loops shall have the following water qualities:

3.3 Passivation for galvanized steel for the first 60 days of operation.

Passivation is normally specified or required only for new systems or systems that have been chemically cleaned. If the system is experiencing excessive corrosion then additional passivation of a particular system may be something to consider, if deemed to be beneficial. Depending on the amount of corrosion, the system may require chemical cleaning to eliminate some of the old corrosion products. In the case of surface corrosion it cannot be stopped, only controlled or reduced. If corrosion is of concern for any of these systems, then most likely normal water treatment procedures were not followed. If these conditions exist, then other solutions may have to be considered. If we find a system that may benefit from additional passivation then we will provide this service if we deem it to be beneficial. There are indicators that will give us good guidance as to the condition of any particular system. If we are awarded this contract we will provide this as part of our normal investigative procedures.

ADDITIONAL SCOPE OF WORK

BUILDING 5 HIGHWAYS

Water Softeners

The Kinetico water softeners at Building 5 are in proper working condition as of our site visit. It is impossible to allow for repairs as part of this contract. It is not practical or economical for the State of West Virginia to pay for something that may not need to be repaired. We can and will help to maintain good condition of the existing softeners and we will provide normal repair services as part of this contract. If it is discovered during the period of this contract that major repairs are necessary, then we will contact the purchasing department to arrange for cost of repairs or replacement units.

DEP BUILDING

Water Softeners

The Kinetico water softeners at the DEP Building will be serviced same as for the Building 5 units. As part of the contract price for the DEP Building we will provide the following services.

The high purity water units for the humidification system requires more than normal service. We will provide necessary replacement of all filters, maintain UV light system, maintain and change out mixed bed resin tanks, which must be changed out at least annually. Also as part of this contract it is required that salt be maintained for each unit. This requires that bags of salt be manually carried to the roof and a sufficient inventory be maintained. The RO system appears to be in good working order according to your maintenance personnel, except that it was indicated the RO unit may need to have the RO pump or motor replaced in the near future. This is not indicated as part of the contract and will be dealt with the same as the water softeners.

CHILLER PLANT COOLING WATER and DEP COOLING WATER

DOLPHIN Cooling Tower Units

The DOLPHIN units supply non-chemical treatment for both of these systems. There is no chemical testing required for these systems. We will provide the legionella testing as indicted in the contract price.
