# GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 12. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 13. Question 1: The question that I have for you to be clarified is with the docking station. Do they want a full automatic/electronic calibration system or would a bump test station be sufficient? You can calibrate and bump test on the bust test stations very easily.

**Answer:** We want full automatic/electronic calibration systems.

Question 2: For the 5 gas detectors for LEL, CO, NO2, O2, and NO, we can only measure 4 of those in a multi gas and the other; we'll say NO, in a single gas MSHA approved monitor. Would this be ok? IF so let me know and I will provide you with the appropriate information.

**Answer:** We must have a detector that reads 5 gases. Methane, oxygen, carbon monoxide, NO, and NO2. We want the capability to measure 100% methane.

#### I. PURPOSE AND SCOPE:

The WV Miners' Health Safety & Training is soliciting bids to establish an open-end contract for multi-gas monitors.

#### II. DEFINITIONS:

The terms listed below shall have the meanings assigned to them as follows:

- 1. "Agency" or "Agencies" means WV Miners' Health Safety & Training.
- 2. "Contract" means the binding agreement that is entered into between the State and the Vendor to provide the Desired Items as specified herein.
- 3. "Desired Item" or "Desired Items" means the list of items identified in Section III, Subsection 1 below.
- 4. "Pricing Pages" means the schedule of prices, estimated order quantity, and totals attached hereto as Exhibit A and used to evaluate the RFQ.
- 5. "Purchasing Division" means the West Virginia Department of Administration, Purchasing Division.
- 6. "RFQ" means the official RFQ published by the Purchasing Division and identified as HST-1227.
- 7. "State" means the State of West Virginia and/or any of its agencies, commissions, boards, etc.
- 8. "Vendor" or "Vendors" means the successful bidder(s).

#### III. GENERAL REQUIREMENTS

1. Desired Items and Mandatory Requirements: Vendor shall provide Agency with the Desired Items listed below. Desired Items must meet or exceed the mandatory requirements as shown below.

The successful Vendor shall provide data logger type monitors.

- 1.1 Technical Requirements:
  - 1.1.1 4 Gas Detectors must detect levels of:
    - a. Carbon Monoxide (CO)
    - b. 5% Methane (CH4)
    - c. Oxygen (O2)
    - 5 Gas Detectors must detect levels of:
      - a. Carbon Monoxide. (CO)
      - b. Nitrogen Dioxide (NO2)
      - c. 5% Methane (CH4)
      - d. Oxygen (O2)
      - e. Nitric Oxide (NO)
    - 4 Gas Mine Rescue Detectors must detect levels of:
      - a. 100% Infrared Methane
      - b. 5% Methane (CH4)
      - c. Oxygen (O2)
      - d. High Range Carbon Monoxide (CO/HI)

### Detectors must be to record and print out findings

- 1.1.2 Detectors must be able to be calibrated in the field.
- 1.1.3 Detectors must include:
  - a. Data link
  - b. Diesel emissions sampling pump and probe
  - c. Lanyard/Cases
  - d. Battery and battery charger for each unit. Battery must have minimum of 12 hour run time.
  - e. Enclosed in a highly visible case and/or reflective.
- 1.1.4 Detectors must have 1 year or longer warranty.

- 1.1.5 Docking stations must include:
  - a. Ability to perform calibrations and bump tests as well as off loads all the instrument data and stores it in a file on a network computer.
  - b. Perform diagnostics on the instrument and will notify the end user of any malfunction
- 1.1.6 Vendor shall provide manufacturers training and hands on training for calibration and maintenance.
- 1.2 Trade-In options
  - 2.2.1 Offer a trade-in for current multi-gas monitors.
  - 2.2.2 Offer a trade-in to upgrade every 2 years.

#### 3.0 SHIPPING

3.1.1 The vendor shall ship all orders to:

3.1.2 The vendor shall deliver units within 30 days from the date of receipt of purchase order or as otherwise directed by the agency.

#### IV. CONTRACT AWARD

- 1. Contract Award: The Contract is intended to provide Agencies with a purchase price on all Desired Items listed above. The Contract shall be awarded to the Vendor that provides the lowest overall total cost for the items listed on the Pricing Pages.
- 2. Pricing Pages: Vendor should complete the Pricing Pages by filling in the attached bid evaluation form. Vendor should complete the Pricing Pages in their entirety as failure to do so may result in Vendor's bids being disqualified.

#### V. ORDERING AND PAYMENT

- 1. Ordering: Vendor shall accept orders by regular mail, facsimile, e-mail, or any other written forms of communication. Vendor may, but is not required to, accept on-line orders through a secure internet ordering portal/website. If Vendor has the ability to accept on-line orders, it should include in its response a brief description of how Agencies may utilize the on-line ordering system. Any on-line ordering system must have the capability to restrict prices and available items to conform to the Catalogue originally submitted with this RFQ. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.
- 2. Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia. Methods of acceptable payment must include the West Virginia Purchasing Card. Payment in advance is not permitted under this Contract.

#### VI. DELIVERY AND RETURN

- 1. Delivery Time: Vendor shall deliver standard orders within 30 working days after orders are received. Vendor shall deliver emergency orders within one (1) working day after orders are received. Vendor shall ship all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met.
- 2. Late Delivery: The Agency placing the order under this Contract must be notified in writing if orders will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for:
  - (a) cancellation of the delayed order, and
  - (b) obtaining the items ordered from a third party.

Any Agency seeking to obtain items from a third party under this provision must first obtain approval of the Purchasing Division.

- 3. Delivery Payment/Risk of Loss: Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders provided that Vendor invoices those delivery costs as a separate charge with the original freight bill attached to the invoice.
- 4. Return of Unacceptable Items: Items that Agency deems unacceptable shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 5. Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any

restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

#### VII. MISCELLANIOUS

- 1. No Substitutions: Vendor shall supply only Desired Items submitted in response to the RFQ. Vendor shall not supply substitute items.
- 2. Vendor Supply: Vendor must carry sufficient inventory of the Desired Items being offered to fulfill its obligations under this Contract. By signing its bid, Vendor certifies that it can supply the Desired Items contained in its bid response.
- 3. Reports: Vendor shall provide quarterly reports and annual summaries to the Agency showing the Agency's items purchased, quantities of items purchased, and total dollar value of the items purchased. Vendor shall also provide reports, upon request, showing the items purchased during the term of this Contract, the quantity purchased for each of those items, and the total value of purchases for each of those items. Failure to supply such reports may be grounds for cancellation of this Contract.
- 4. Contract Manager: During its performance of this Contract, Vendor must designate and maintain a primary contract manager responsible for overseeing Vendor's responsibilities under this Contract. The Contract manager must be available during normal business hours to address any customer service or other issues related to this Contract.
- 5. Mandatory Requirements: The terms "must," "will," "shall," "minimum," "maximum," or "is/are required" identify a mandatory contract requirement. Decisions regarding compliance with any mandatory requirements shall be at the sole discretion of the Purchasing Division. Failure on the part of the Vendor to meet any of the mandatory specifications shall result in disqualification of the bid.
- 6. Waiver: The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or remedy, but the same shall continue in remain in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.

# **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compliance with the requirements as stated.
