OPEN END CONTRACT TO FURNISH STONE FOR THE WEST VIRGINIA STATE RAIL AUTHORITY

The West Virginia Purchasing Division, for the West Virginia State Rail Authority is soliciting bids for a vendor or vendor(s) to furnish all labor, material and equipment necessary to supply stone to the West Virginia State Rail Authority at the locations and under the conditions specified. It is also to be expressly understood that this contract does not obligate the spending unit to purchase any quantity of material. The quantities listed in this RFQ are only estimates.

SPECIFICATIONS

All material furnished shall be in accordance with the appropriate specifications of the American Railroad Engineering Association guidelines.

a) Ballast

Ballast shall be crushed stone or crushed slag and shall conform to the current AREMA "Specifications of Prepared Stone, Slag and Gravel Ballast". Size of Ballast shall be AREMA #3 as indicated below:

BIDDING INSTRUCTIONS

Size of Opening

Vendors may bid any or all items on the bid sheet. Vendors shall provide the information requested under the bidding schedule section.

The State Rail Authority may purchase aggregate and stone F. O. B. Vendors' Storage Site. The bid price F. O. B. Vendor's Storage Site shall include loading of the SRA trucks by the vendor.

Vendors shall bid a price per ton for each type of material at each location specified.

CONTRACT AWARD

The low bidder for each location will be awarded a contract to establish a unit price for those items bid.

VENDOR'S INVOICES

Vendor's invoices must be submitted in original and two copies and contain the following:

- 1. All weight ticket numbers for material delivered during the invoicing period.
- 2. West Virginia State Contract Purchase Order (SCO) number and this contract number.
- 3. Total quantity and unit price with the total cost of each type of material furnished. (Total quantity invoiced shall be scale weights (supported by weigh tickets)

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compliance with the requirements as stated.
