

General Instructions

Purpose of Form

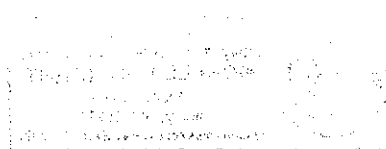
