Questions and Answers for the Pro-Drive "X" Series boat and motor.**Question:**

An "X" Series Boat is a commercially rated boat with no floatation. While some federal and state government agencies do allow commercially rated boats and we have built many in the past, some do not. It appears that West Virginia wants a boat that meets Coastguard standards. This would have to be our "SBX" Series. Details and spec's of these models are on our website. I would need to know in fact if it is the "X" Series being requested with a commercial rating or the SBX with a Coastguard rating. Our SBX Boat is a true self bailing boat and needs on bilge pump.

Answer:

The Pro-Drive "X" Series boat does not comply with the U.S. Coast Guard Recreational Safety Standards and was listed in error. The Pro-Drive "X" Series is replaced by the Pro-Drive "SBX" Series or equal to meet the standards.

Question:

While I am certain our boats would meet or exceed NMMA requirements we have not applied for this designation.

Answer:

The language that stated the boat construction must be NMMA Certified was removed on all three boat specifications.

Question:

On the SBX the standard tank is located below the extended deck and is 12 gal. On an X Series boat a 6 gal boat tank is provided. Due to strict EPA regulations on marine fuel tanks, we cannot build fuel tanks.

Answer:

Built-in or portable fuel tank is acceptable for the Pro-Drive "SBX" or equal boat.

Question:

Our motors come standard with two blade propellers and is recommended, however a three blade can be provided.

Answer:

Two or three blade propellers are acceptable for the Pro-Drive boat motor.

Question:

Lastly, the spec says the motor must be compatible with boat spec's for a Frontier 1756sc Jon. This is confusing to me if a Pro-Drive boat is being requested.

Answer:

Typographical error. The Pro-Drive Vanguard 36 HP Gear-Driven motor must be compatible with the Pro-Drive boat.
