- Q1: P2. It appears specification 0005 & 0006 are identical?
- A1: Line Item No. 6 on Page 2 of the RFQ has been changed from "Lithium Polymer for Motorola XTS2500 Portable Radio" to "Nickel-Metal Hydride battery for Motorola APX 7000 Portable Radio." The Pricing Page has also been revised to correct the error. See Attachment B.
- Q2: P22. Section 3.4.3 states "each battery must maintain a minimum of 80% of rated capacity for 24 months" which conflicts with the correct statement in 3.3.4 "80% of its rated capacity for 12 months" I believe 3.4.3 should state "each battery is warranted for 24 months against any defects in manufacturing or workmanship" Please clarify.
- A2: To delete the following section in its entirety
 - 3.4.3 Nickel-Metal Hydride Battery for Motorola XTS-2500 portable radio must meet the following specifications: each battery shall be a 7.2 volts, 2700mAh, Nickel-Metal Hydride, each battery must maintain a minimum of 80% of rated capacity for 24 months, shall be a Honeywell H 9858 M, or equal.

And replace with the following -

- 3.4.3 Nickel-Metal Hydride Battery for Motorola XTS-2500 Portable Radio must meet the following specifications: each battery shall be a 7.2 volts, 2700 mAh, Nickel-Metal Hydride and shall be a Honeywell H 9858M, or equal.
- A2a: To delete Section 3.3.4, following Section 3.4.3 on page 22 of the RFQ in its entirety. The section was incorrectly numbered.
 - 3.3.4 Nickel-Metal Hydride battery for Motorola XTS-2500 portable radio shall be guaranteed to be free from defects in materials and workmanship and shall maintain a minimum of eighty (80) percent of its rated capacity for twelve (12) months from the date of shipment under normal use.

And replace with the following -

- 3.4.4 Nickel-Metal Hydride battery for Motorola XTS-2500 portable radio shall be guaranteed to be free from defects in materials and workmanship and shall maintain a minimum of eighty (80) percent of its rated capacity for twenty-four (24) months from the date of shipment under normal use.
- Q3: P23. Section 3.5.3 specifies "7.2V, 2700mAh, Lithium-Polymer" as found in Honeywell, however that specification would be "7.2V, 3600mAh Lithium Polymer" Please clarify.
- A3: The correct mAh should be 3600. It should read: "7.4 volt, 3600 mAh."

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.
