- Q.1. The text on the first page says that this is a one-time purchase of three storage hardware devices and software, but the spec sheet only allows for 2. Which is the correct number?
 - A.1. The correct number is three (3). There is Quantity two (2) NetApp FAS 2240-4 Hybrid/mixed Shelf with four (4) 200GB SSD and (20) 2TB drives; dual controllers or equal and Quantity one (1) NetApp FAS 2240-4 (24) 1 TB drives; dual controllers or equal listed on Exhibit A Pricing Page.
- Q.2. Will the storage devices all be located in the same physical location?
 - A.2. No; they will be located in different locations.
- Q.3. Is the purpose of the storage be for virtualization only, or will there be file (NFS level) access as well?
 - A.3. Currently they will be only used for virtualization only, however as stated in 3.1.1.4. Storage Hardware must be compatible with ISCSI, NFS, CIFS, and fibre channel protocols. The agency would like the options to be there.
