Project Approach







Eleanor CHP Facility Repairs

The Eleanor Control Humidity Preservation (CHP) facility is composed of two large fabric structures with a crossover connector near the east end. The manufacturer of the structures is Clamshell Buildings (www.clamshell.com). The structures are currently occupied by Naval Special Warfare (NSW) Ops Stock. The west end of the northern structure has partially collapsed. This area of the building suffered damage during the wide spread derecho storm on June 29, 2012, and this damage became worse during a local wind storm during the night of October 31, 2013.

After the October 31st storm, Moment Engineers, Inc. visited the site at the request of MAJ Melvin P. Hodges to perform an emergency assessment and prepare a written report. This report provided an outline of the construction of the facility and an assessment of the storm damage. Due to the inherent proprietary nature of the structural components, the report recommended that he manufacturer be closely involved in the repair. We have recently been in contact with Clamshell's engineering department to discuss repair options. From this conversation, we understand that the series components which make up the trusses of the dome are no longer manufactured. Our proposed approach therefore is to remove the damaged domed end to the first upright truss and install a vertical wall similar to the eastern end, as shown in the lower picture to the left.

Center for National Response Mezzanine Support

The Center for National Response (CNR) is an operational training facility located in the Memorial Tunnel originally constructed for the WV Turnpike. It is a multipurpose facility that provides ten training venues for Federal, State and Local organizations. One of the venues is a rubble area. This can simulate a collapsed parking garage or building due to an earthquake or terrorist initiated event. In order to simulate various scenarios within the venue, the floor area needs to be rearranged with a forklift. The columns supporting the observation platform would often be knocked out of plumb during the arrangement of an exercise. Moment Engineers provided engineering design services to suspend the platform from the concrete roof of the tunnel so that the columns would no longer be required for the mezzanine support.

Structural Evaluation of Camp Dawson Chalets and Rappel Tower

In 2005, the exterior deck on the chalet housing units at Camp Dawson had deteriorated due to weather exposure. Also at the facility, the wooden rappel tower exhibited signs of distress, including vertical deflection and horizontal sway. Moment Engineers provided services for the evaluation of the integrity of these structures. These services included inspection of their current condition, structural analysis, development of a safe loading capacity, and development of options for corrective action.

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

- "Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.
- "Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.
- "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (*W. Va. Code* §61-5-3) that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.
