

Ladies and Gentlemen:

Further, each team member has been carefully selected for his or her specific expertise and contribution to this project, ranging from expertise with State-level Section 5310 Program administration to public outreach and consensus building for coordinated transportation services. Specifically, the RLS team possesses a solid background and experience with Moving Ahead for Progress in the 21st Century (MAP-21) legislation, and Federal Transit Administration programs, including Sections 5310 (including the former Section 5317 program) and 5311 (including the former Section 5316 program); extensive experience in providing technical support and assistance to State DOTs; and successful development and implementation of Coordinated Human Services and Transportation Plans.

For more than a quarter century, RLS has focused on providing valuable technical assistance and support to public transportation and human service transportation systems across the country, including many in West Virginia. RLS has had the privilege of assisting the DPT and several of West Virginia's urban and rural transit systems for more than eight years. With its staff of public and human service agency planning experts, RLS is prepared to again, and looks forward to, assist the DPT with the planning and technical assistance activities included in RFQ Number PTR14022.

Each team member's experience and credentials are more fully described in the appropriate sections of the enclosed RLS response along with resumes and specific examples of RLS' work experience and performance. RLS recently expanded its team to include Mr. Kelly Shawn, formerly of the Community Transportation Association of America, and Mr. Michael Noel, formerly of Lazaro & Noel Consultants & Trainers. If selected for this project, Kelly and Michael will offer decades of transit expertise along with fresh insight to the RLS team's approach to coordinated transportation planning in West Virginia.

Our proposed Project Manager for this project is Ms. Laura Brown. Laura was the Project Manager and major contributor to the 2011 West Virginia Regional Coordinated Transportation Plan Updates. While the 2011 database of local stakeholders, local media contacts will require minor updates, that information combined with Laura's awareness of both the existing services and the historical transportation challenges and opportunities in each county will ensure that the MAP-21 updates are completed in the most comprehensive and cost-and time-efficient process. Ms. Brown has been a major contributor to more than 40 local rural and urban coordinated public transit-human service agency transportation plans and updates, including seven MAP-21 compliant plan updates in Ohio, Indiana and South Dakota. She is extensively familiar with MAP-21 regulatory requirements as well as the other Federal, State, and Local funding programs that can be leveraged through coordinated transportation efforts.

As Project Principal, I have been extensively involved in the conduct of all RLS commitments, including those in West Virginia. RLS & Associates, Inc. (RLS) is prepared to dedicate the necessary staff and time to the project to ensure that all work is conducted responsively and responsibly. Because of the diverse expertise of the RLS staff, and their close proximity to West Virginia, we are confident that we can address all needs and requests presented by the DPT or its subrecipients in a timely and cost-efficient manner with excellent quality.

Ms. Robbie Sarles will be responsible for project oversight, quality assurance, adherence to the timeline and budget, and client satisfaction. She will be available to meet with the DPT to discuss project status, whenever required or requested. Ms. Sarles will be dedicated at a level of 10% availability to perform project work.

Ms. Laura Brown will serve as a Project Manager and will be coordinating the public outreach activities and schedule of Human Service Coordination Plans and Updates and reviewing the opportunities for and actual level of local input at each step in the planning process for completeness, and compliance with FTA, MAP-21, and DPT requirements. Ms. Brown will also be the primary lead in preparing the Executive Summary and the RLS primary point of contact for all local coordination plan participants.



Mr. Kelly Shawn and Ms. Julie Schafer will serve as the Lead Consultants during local public meetings and will lead the local stakeholders through development of the needs assessment and prioritized coordinated transportation strategies. In this capacity, Mr. Shawn and Ms. Schafer will be the primary leads for the team by working with local stakeholders to identify goals and gaps in service by county and by region, and identification of best practices in local coordination activities. They will also be available for progress meetings and presentations to the DPT and West Virginia Transportation Coordinating Council, upon request of the DPT. Mr. Shawn will be dedicated at a level of 80% availability to perform project work, and Ms. Shafer will be dedicated at 75% availability to this project.

Mr. Richard Garrity, Mr. Michael Noel, and Ms. Rosamary Amiet have a combined total of over 100 person-years of experience in the transit industry, and will be tasked primarily with providing technical assistance to the Division, WVTCC or MPO coordination projects and/or activities. On-going technical assistance to support will be available from the team, as needed. The above noted team members will also provide a supportive and advisory role in the review of Plans, Evaluations, and Updates. Mr. Garrity will be dedicated at a level of 15% availability, Mr. Noel will dedicate 80% availability, and Ms. Amiet will dedicate 35% availability to perform technical assistance for the project.

Ms. Patti Noel, Mr. Alex Schultze, and the RLS GIS technician, Mr. Zach Kincade, will provide support to the Lead Consultants in each task and provide expertise pertaining to creative, appropriate, and successful project outcomes. Ms. Noel will be dedicated at 90% level of availability to perform project work. Mr. Schultze will be dedicated at 60% level of availability to perform project related work. Our GIS technical support staff will be dedicated at 85% level of availability.

The table below illustrates the level of effort or availability for each staff member. In preparation for the tasks, RLS has also projected the specific tasks on which each RLS team member will focus efforts.



Under Ms. Sarles' direction, RLS has grown into a widely respected consultant company which provides transportation management and operations consulting services to transportation providers and communities throughout the United States, Canada, and the Virgin Islands. Ms. Sarles is also an Adjunct Professor at the Wright State University in Dayton, Ohio, for the Public and Social Service Transportation Certification Program.

As the Principal-in-Charge of this effort, Ms. Sarles will be tasked with the oversight of the work effort, including budget compliance and staff assignments. Ms. Sarles will meet with DPT staff as appropriate to discuss project progress and provide technical advice.

#### Laura Brown, Senior Associate

Ms. Brown is the proposed project manager for the project. She brings a diverse background of over 11 years of transit planning experience supplemented with financial management experience. Her professional focus while at RLS has been primarily set on coordinated and regional transportation planning efforts. Her current and recently successfully completed projects include Project Manager of the West Virginia Statewide Regional Coordinated Transportation Plan Updates, including the KYOVA TMA Coordinated Transportation Plan;



Indiana Statewide Coordinated Public Transit Human Services Transportation Plan Updates (2012-2013) (which included 11 rural regional coordinated transportation plans); Coordinated Public Transit Human Services Transportation Plan Update for the Indianapolis region; Union County Ohio Coordinated Human Services Transportation Plan Update (2013); Study to assist the Lowcountry RTA in expanding the availability of the Central Indiana Regional Transportation Authority (CIRTA) regional On-Demand/Rural Transportation Plan; the Coordinated Transportation Action Plan for Lee-Russell Counties Alabama, a United We Ride pilot project for Alabama DOT and Alabama Department of Senior Services; Coordinated Public Transit-Human Services Transportation Plan Updates for Anchorage and Sitka, Alaska; and, Coordinated Public Transit-Human Services Transportation Plan Feasibility Study for Delaware County, NY, which resulted in implementation of a human services coordination program.

For this project, Ms. Brown will be the Project Manager for preparing and updating regional Coordinated Public Transit Human Services Transportation Plans and ensuring that all aspects of the plans are compliant with FTA regulations and meet the requirements set forth by MAP-21 regulations and the West Virginia DPT. Ms. Brown will also be available to provide technical assistance to the Division and local/regional coordination partners, as appropriate.

#### Kelly Shawn, Senior Associate

Mr. Kelly Shawn recently joined RLS & Associates, Inc. to lead RLS' tribal transit and service operations division. He brings 26 years of experience in the transportation industry, most recently with the Community Transportation Association of America (CTAA). An experienced trainer, facilitator, and project manager, Mr. Shawn has worked with dozens of diverse community and tribal transit systems during his career. His experience with Medicaid, privately contracted, and intercity transportation services add to his impressive background and professional understanding of the transportation industry. Mr. Shawn's technical assistance, project manager, and training experience, combined with his strong knowledge and background in rural and tribal transit make him a valuable addition to the RLS team.

Mr. Shawn is concentrating on service and operations planning projects for RLS and in his short time with RLS, has served as the Project Manager for the Yankton Transit, South Dakota, Coordinated Transportation Plan Update; lead investigator for the Bloomington Transit, Indiana, Title VI Policy and LEP Plan development; and Project Manager for the Wichita Transit Paratransit Service Evaluation. He is also conducting compliance reviews for the Oregon DOT.

Prior to RLS, Mr. Shawn was the Assistant Director for Technical Assistance Programs for the Community Transportation Association of America (CTAA). While at CTAA, Mr. Shawn provided on-site technical assistance to urban, rural and tribal communities nationwide assisting in the development of coordinated accessible transit and facility service plans. His responsibilities included work with local, tribal and state governments, private industry, human service agencies, and Federal agencies on transit solutions for economic development, employment transportation, and general public transit. During his tenure at CTAA, Mr. Shawn became versed in the many issues surrounding Medicaid and non-emergency medical transportation (NEMT). He also developed and provided training to transit professionals, state transit associations and



national audiences on Federal regulations, transit management, driver training and customer service. While Mr. Shawn's projects gave him a diverse, national perspective of transit, perhaps none made as significant an impact as his work on-site with local, state and Federal officials to develop transportation solutions for persons with disabilities and displaced residents in the aftermath of Hurricanes Katrina and Rita at the request of Louisiana DOTD. Prior to CTAA, Mr. Shawn was the Contract Manager with Metro Access of Maryland where he managed a \$2 million paratransit provider contract for Washington Metropolitan Area Transit Authority (WMATA), working with contracted broker staff to achieve performance standards and maintain the highest level of customer service for persons with disabilities while complying with the Americans With Disabilities Act. He also managed a Medicaid Transportation contract Prince Georges County and private pay transportation providers to provide service to ambulatory riders requiring transportation to medical services. Annual ridership for this service was around 200,000. Mr. Shawn interacted with WMATA management, local county officials, the Department of Human Resources, and Maryland State officials to improve this service.

Finally, Mr. Shawn was Operations Manager for American Coach Lines, Inc., one of the largest charter and tour bus companies on the East Coast, and was General Manager of Ground Transportation for the Washington Flyer, where he managed bus and van transportation services at Washington National (Reagan) Airport.

Mr. Shawn earned a B.S. in Business Administration from Lynchburg College, Lynchburg, VA and holds various professional certificates, including Passenger Service and Safety (PASS) and CTAA Certified Master Trainer. #### <u>Development of a Coordination Toolkit and Coordination Plan Template</u> <u>West Virginia Department of Transportation (WVDOT)</u>

## 2013 Indiana Regional Coordination Plans and Updates Indiana Department of Transportation (INDOT)



**Project In-Progress**

Assistance has been provided in the form of developing sample policy and procedural manuals, drug and alcohol recordkeeping procedures, system brochure assessment, contract rate evaluation, and regulatory compliance reviews.

◆ Drug and Alcohol Program Compliance State Oversight Program Development RLS provides ongoing technical assistance to the Ohio Department of Transportation regarding regulatory compliance issues. Specifically RLS has provided guidance to ODOT regarding the roles, responsibilities, and procedures for performing state management oversight of the State's Section 5311 systems' drug and alcohol testing programs. ODOT monitoring procedures and



checklists were modified to address compliance issues identified for other states through the FTA compliance audit process.

#### Contract Rates White Paper

Issues surrounding contract service and the methods for developing a fully allocated rate structure are summarized in this paper. The White paper illustrates the basic approach to the appropriate use of rural transit funds and other Federal and State subsidies in providing mobility for a special contracting group. Suggested methods for establishing equitable payment by the contracting group, as well as for determining the positive and negative fiscal impacts of providing contract service were outlined in a step by step format.

◆ Development of White Papers on Americans with Disabilities Act Issues RLS in concert with Multisystems developed clarified interpretations and applicability of the ADA in regards to vanpools, social service agencies, demand response general public transportation systems, and coordinated transportation systems. The white papers were based on information, opinions, and interpretations from the U.S. Department of Transportation, the Federal Transit Administration, and the U.S. Department of Justice. The paper defined public entities and services, and the requirement for equivalent service and program access.

#### Resource Inventory

In June 1999, the Ohio Department of Transportation Office of Transit began this effort by compiling an inventory of resources that are available to support community transportation. The goal of this project was to "develop a comprehensive inventory of Federal, state, and local programs and resources that are available to plan for and support public transportation and welfare reform initiatives." The RLS efforts in the project expanded on the 408 Transportation Work Team's efforts by compiling information about more than 80 Federal, state, and non-governmental programs that support community transportation. Inventories were completed for 12 Ohio counties.

#### Scheduling / Dispatch Assistance for Lancaster

RLS and KFH reviews the current reservations, scheduling, and dispatch functions of the City of Lancaster's Taxi Token Program. After the initial assessment, new policies and procedures were developed that addressed service quality, travel time, drop-off time, and time calls.

 Enhance TGIS System to Include Inventory Data for Section 5311 Management Performance Review

Enhanced and added specific capabilities to the Transit Grants Information System (TGIS) to assist the three-year Management Performance Review Program.

#### Video Production

Provided assistance to ODOT in producing a high quality, versatile marketing video. RLS & Associates, Inc. provided pre-production decision-making and planning assistance to the project. They selected the production company, developed an appropriate production schedule and performed the necessary research to ensure an accurate script and realistic theme. During production, RLS staff secured the necessary props, uniforms, vehicles and persons to provide an

Section 5311 Funding Allocation Formula Assessment

Section 5310 Program Review

The review process focused on the current application process, evaluation and selection criteria, vehicle procurement, monitoring, and disposition, and overall program administration. A summary of recommendations was made to ODOT.

♦ Ohio Coordination Program Evaluation

Additionally, RLS assisted in the determination of evaluation criteria to review potential funding projects under this program and oversee the development of a marketing brochure to promote the availability of intercity bus service in Ohio.

Rail Fixed Guideway NPRM Review

RLS & Associates conducted a review of the Notice of Proposed Rule-Making (NPRM) 49 CFR 659 which addresses state agency oversight of rail fixed guideway systems. In addition, an assessment of the implications for ODOT was made.

Rideshare Program Evaluation

The primary intent of the work effort was to document the effectiveness and performance of the individual agency programs and to develop a corresponding performance-based funding allocation. The data was later analyzed, put into spreadsheet format, and used to establish alternative allocation methods. ODOT later used this data to assist in its initial evaluation of the role the DOT should have in local rideshare programs.

Rideshare Program Review

RLS & Associates conducted a review of the Rideshare Program which promotes car and vanpooling for commuters in Ohio. An analysis of the current administration process was conducted, which focused on program development, guidelines, and monitoring. The review included a peer analysis of what other states are doing with their Rideshare Programs and a summary of findings and recommendations.

• Rideshare Program Funding Allocation Methodology RLS & Associates developed several alternatives for funding the Rideshare Program agencies using a performance-based methodology. RLS conducted a database survey to collect inputs for the new methodology.

## Ohio Mobility Improvement Study Ohio Department of Transportation (ODOT)



#### <u>Lowcountry South Carolina Coordinated Public</u> <u>Transportation Expansion Plan</u>

#### **Lowcountry Regional Transportation Authority**





#### Stevens Point Transit Services Expansion Plan Stevens Point Transit, Stevens Point, WI (Section 5307 Recipient)

Recognizing that provision of affordable transportation services is essential to placing individuals in sustainable employment situations, the North Central Wisconsin Workforce Development Board (NCWWDB) and Stevens Point Transit and the Community Transportation Association of America (CTAA) initiated this plan to enhance transportation services throughout the study area; including the most rural areas of



Portage County where access to employment and community services was extremely limited. Recommended service enhancements will build upon the successful fixed routes, demand response, taxi, and volunteer transportation currently provided for the general public and University of Wisconsin Stevens Point. # Transit Consolidation Implementation Plan and Joint Transportation Development Plan Licking County Area Transportation Study (LCATS) (Section 5307 Recipient)

At the onset of the study, Licking County Transit Board and the City of Newark were two separate transit systems operating demand response public transportation within close proximity.



The City of Newark is the county seat of Licking County. Duplications in trip origins and destinations, administrative functions, and maintenance, as well as confusion for the passengers about fare structures and providers, brought the County and City together to explore opportunities for consolidating the services. RLS & Associates, Inc. assisted the City and County with implementation of a consolidated transportation program that would reduce duplications and improve efficiency while enhancing service to the local community. Phase 1 of the project involved the consolidated implementation plan. #### <u>Tanana Chiefs Conference Corridor Study</u> <u>Tanana Chiefs Conference, Alaska</u>

RLS & Associates, Inc. provided technical assistance to the Tanana Chiefs Conference (TCC). along with the Community Transportation Association of America (CTAA), in improving transit service in five highway corridors around Fairbanks Alaska adjacent to tribal lands of Conference members. The member tribes of the TCC face unique transportation challenges, only nine tribes are connected by road. For some of the villages off the road system, mobility alternatives include boats on rivers in summer, and snow machines overland in winter. The major destination for villages that have access to the road system in Fairbanks. There are also non-Native communities along these highway corridors leading into Fairbanks, which likewise have substantial transportation needs focused on Fairbanks. Transportation services developed as part of this project will serve the non-Native communities as well as the Native villages in order to achieve the critical mass to sustain transportation services. Extensive outreach efforts, including public meetings in the Native and non-Native communities were conducted throughout the planning effort to understand needs and existing resources. Service alternatives and service and organizational implementation strategies were presented with the final report, along with a comprehensive list of performance measures, ridership expectations, line-item operating and capital budgets, and recommendations for revenue sources. RLS also presented a



workshop for interested communities to discuss step-by-step procedures for implementing a new coordinated transportation effort.



#### Erie County Feasibility and Implementation Plan Erie County Board of Developmental Disabilities (Section 5311 and 5310 Recipients)



## Randolph and Montgomery Counties, NC Community Transportation Service Plan (CTSP) North Carolina Department of Transportation (NCDOT)

The rural/on-demand transit providers of the eight counties that surround Marion (Boone, Hamilton, Hancock, Hendricks, Johnson, Madison, Marion, Morgan, and Shelby) partnered with RLS & Associates, Inc. to

#### V-Line Public Transit Route Study City of Valparaiso V-Line

RLS & Associates, Inc. is conducting this route study joined by subcontractor Nelson\Nygaard. The V-Line transit system is operated as a deviated fixed route service in Valparaiso, Indiana. 

#### Niles Michigan Transit Development Plan City of Niles

Faced with declining revenues, the City of Niles was forced to reduce its hours of operation and staff. Unfortunately, they found that ridership also declined. The City of Niles hired RLS & Associates, Inc. to assist the City with making systematic improvements to their valuable Dial-A-Ride service. RLS completed a comprehensive analysis of the Dial-A-Ride service and made recommendations to improve the effectiveness of the system while ensuring its sustainability.
