

# ATTACHMENT A PRI1500000005 - Addendum No. 1

#### **Questions:**

- Q1: There is no gross vehicle weight rating listed on this truck spec. Is there a particular GVW rating they are requesting?
- A1: Minimum 19,500
- Q2: Are they requesting a conventional or a cab over design?
- A2 The Agency prefers a cab over design.
- Q3: Can the minimum dual 30 gallon tanks requirement be met by a single 60 gallon tank?
- A3: The Agency requires a minimum 60 gallon tank. This can be dual 30 gallon or single 60 gallon.
- Q4: On the heated tanks requirement, would a heated fuel water separator meet this requirement, or does the customer want an aftermarket fuel tank heater with a switch installed like for example an Artic Fox?
- A4: The Agency prefers the Artic Fox; however, will accept an alternate heated tank. If a heated fuel water separator meets the heated tank requirement this would be acceptable. The mandatory specification is a "heated tank".
- Q5: Having hydraulic brakes, this unit will have to be under 26,000 GVW. With this in mind, few manufacturers offer an engine brake for that size engine. An engine brake works off of the compression of the engine. Is the customer actually wanting an exhaust brake which works by restricting the exhaust?
- A5: The engine brake is preferred, but not mandatory. Vendor can bid either type of brake.
- Q6: To clarify, when the customer requests "rear truck lifts", do they mean outriggers which will take the load off of the truck's suspension during loading, or do they have something different in mind?
- A6: The Agency is referring to an actual lift that lifts the truck to align the truck with varying dock heights.
- Q7: Since the hydraulic lifts are "preferred" but not mandatory, and would cost more than a hand crank lift, can they be listed as a price option on our bid submittals, or should we submit two different bids, one with hand crank and one with hydraulic?
- A7: Change Section 3.1.2 Truck subsection I to read:

#### 3.1.2 Truck

I. Must have rear truck hydraulic lifts.

- Q8: In placing bodies on cab and chassis's, the most important measurement is the cab to axle measurement. Because different manufacturers cab size varies, which would affect the correct cab to axle measurements can we change the wheelbase measurement to read "appropriate manufacturers suggested wheelbase to accommodate a 20' box with a liftgate"?
- A8: To change Section 3.1.2 Dry Freight Box subsection B to read -
  - "appropriate manufacturers suggested wheelbase to accommodate a minimum of a 20' box with a liftgate."
- Q9: Body companies are sometimes out 5 6 weeks on their bodies not to mention the amount of time included in freight. Unless a vendor has this unit sitting on their lot, the delivery within 60 working days will be nearly impossible to meet. Will the agency consider bids which cannot meet the 60 day deadline if an alternate deadline is given, or will that all fall under the 6.2 "Late Delivery" clause?
- A9: Delete Section 6.1 in its entirety and replace with the following -
  - 6.1 Shipment and Delivery: Vendor shall ship the Contract Items immediately after being awarded this Contract and receiving a purchase order or notice to proceed. Vendor shall deliver the Contract Items within 120 calendar days after receiving a purchase order or notice to proceed. Contract Items must be delivered to Agency at 617 Leon Sullivan Way, Charleston, WV 25301.
- Q10. Does the customer want the lift gate to be power down or gravity down?
- A10: See Section 3.1.2 Lift Gate sub-section C which states gravity down.
- Q11: I'm working on this bid on (2) 20' box trucks, my question is, what GVW do they need and I cannot meet the 50 working day to deliver (I need 100 working day).
- A11: See Response No. 9 above.

- 18. APPLICABLE LAW: This Contract is governed by and interpreted under West Virginia law without giving effect to its choice of law principles. Any information provided in specification manuals, or any other source, verbal or written, which contradicts or violates the West Virginia Constitution, West Virginia Code or West Virginia Code of State Rules is void and of no effect.
- 19. COMPLIANCE: Vendor shall comply with all applicable federal, state, and local laws, regulations and ordinances. By submitting a bid, Vendor acknowledges that it has reviewed, understands, and will comply with all applicable law.
- 20. PREVAILING WAGE: On any contract for the construction of a public improvement whose cost at the time the contract is awarded will be paid with public money in an amount greater than \$500,000. No Change shall be implemented by the Vendor until such time as the Vendor receives an approved written change order from the Purchasing Division.
- 23. WAIVER: The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or remedy, but the same shall continue in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.
- 24. SUBSEQUENT FORMS: The terms and conditions contained in this Contract shall supersede any and all subsequent terms and conditions which may appear on any form documents submitted by Vendor to the Agency or Purchasing Division such as price lists, order forms, invoices, sales agreements, or maintenance agreements, and includes internet websites or other electronic documents. Acceptance or use of Vendor's forms does not constitute acceptance of the terms and conditions contained thereon.
- 25. ASSIGNMENT: Neither this Contract nor any monies due, or to become due hereunder, may be assigned by the Vendor without the express written consent of the Agency, the Purchasing Division, the Attorney General's office (as to form only), and any other government agency or office that may be required to approve such assignments. Notwithstanding the foregoing, Purchasing Division approval may or may not be required on certain agency delegated or exempt purchases.
- 26. WARRANTY: The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- 27. STATE EMPLOYEES: State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- 28. BANKRUPTCY: In the event the Vendor files for bankruptcy protection, the State of West Virginia may deem this Contract null and void, and terminate this Contract without notice.

- 29. CONFIDENTIALITY: The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in <a href="http://www.state.wv.us/admin/purchase/privacy/default.html">http://www.state.wv.us/admin/purchase/privacy/default.html</a>.
- 30. DISCLOSURE: Vendor's response to the Solicitation and the resulting Contract are considered public documents and will be disclosed to the public in accordance with the laws, rules, and policies governing the West Virginia Purchasing Division. Those laws include, but are not limited to, the Freedom of Information Act found in West Virginia Code §§ 29B-1-1 et seq. and the competitive bidding laws found West Virginia Code §§ 5A-3-1 et seq., 5-22-1 et seq., and 5G-1-1 et seq.

If a Vendor considers any part of its bid to be exempt from public disclosure, Vendor must so indicate by specifically identifying the exempt information, identifying the exemption that applies, providing a detailed justification for the exemption, segregating the exempt information from the general bid information, and submitting the exempt information as part of its bid but in a segregated and clearly identifiable format. - 38. ADDITIONAL AGENCY AND LOCAL GOVERNMENT USE: This Contract may be utilized by and extends to other agencies, spending units, and political subdivisions of the State of West Virginia; county, municipal, and other local government bodies; and school districts ("Other Government Entities"). This Contract shall be extended to the aforementioned Other Government Entities on the same prices, terms, and conditions as those offered and agreed to in this Contract. If the Vendor does not wish to extend the prices, terms, and conditions of its bid and subsequent contract to the Other Government Entities, the Vendor must clearly indicate such refusal in its bid. A refusal to extend this Contract to the Other Government Entities shall not impact or influence the award of this Contract in any manner.
- 39. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

"Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
  - c. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater.

For the purposes of this section, the cost is the value of the steel product as delivered to the project; or

- d. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.
- 43. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. 


