

7.4 Operating and Service Manuals and Parts Lists: An operator's manual must be included with each unit upon delivery. A "line sheet" (if applicable) and the "Equipment Preventative Maintenance Questionnaire", (Exhibit "B") must be with pilot unit upon delivery, Attn: Marcia Lee. There must be 12 service/shop/maintenance manuals and 14 parts manuals; CD-ROM is preferred in lieu of parts manuals. Manuals shall be delivered upon completion of delivery of total units. Failure to do so will delay payment.

7.5 Training: Manufacturers and/or dealers will be required to stage a thorough seminar on the subjects of Preventative Maintenance, Operator, and Mechanic Training. Standard Warranty

1 year or 1800 hours from in-service, whichever comes first.

The warranty period begins at the first rental or retail of the LBX machine, or immediately after 75 hours of demo time. This warranty is transferable provided all required and requested inspections and reports are performed and filed.

Full machine warranty, including engine*. This warranty does not cover damage due to application or attachment related repairs. This warranty covers repairs due to material and/or workmanship only and not the wear out of a part or component. Minor repairs and/or consumables are not covered, including, but not limited to o-rings, filters, fluids, pins, bushings, bulbs, undercarriage components such as sprockets, bottom rollers, carrier rollers and idlers.

Travel and mileage covered during the standard warranty only up to \$300 combined per claim.

All excavators sold with Tier 3 or Tier 4 engines qualify for the following engine warranty:

2 years / 3000 hours (whichever comes first)

2 years / 2000 hours (whichever comes first) for electrical components.

Engine Warranty -- Isuzu

LBX warrants to the buyer that the engine sold with this warranty when shipped, will meet all required specifications and will be free from defects in material and workmanship. The duration of this warranty is described in the text below.

ENGINE WARRANTY TERMS

All machines sold with Tier 3 or Tier 4 engines qualify for the following engine warranty*:

2 years / 3,000 hours (whichever comes first)

*2 years / 2,000 hours (whichever comes first) for electrical components.

All claims for failures due to defect in material and/or workmanship must be filed with LBX on the WOW system within 30 days of the repair date. All parts must be held for inspection for 90 days from the claim processing date.

The LBX engine warranty does not apply due to any of the following:

1. Engine parts purchased from a source other than LBX.
2. Any engine which has been subject to neglect, misuse, accident, an unapproved application, or any unapproved parts, fittings, etc.
3. Any engine that has been repaired or modified that in the judgment of LBX, adversely affects the performance and/or reliability of the engine.
4. Any engine which has a failure due to improper maintenance and/or lack of preventive maintenance or service, including turbocharger failures due to improper start-up or shut down.
5. All tune-ups and normal maintenance including but not limited to: valve adjustments, service items, gaskets, cylinder liners, starter brush, starter pinion and clutch, air cleaner elements, all filters, glow plug, control resistance, rubber hose, vinyl pipe, injection nozzle, fan belt, rust due to storage and/or fuel related, oil, antifreeze, etc, are the responsibility of the LBX dealer.
6. Any engine which has a failure due to extended storage as determined by the LBX Product Support Manager.
7. Any fees or loss of operating time due to the engine being repaired.

This warranty is subject to change at the discretion of LBX.

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

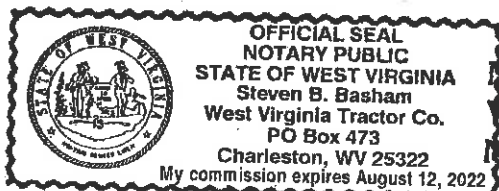
