

Anderson Hydra Platforms warrants each new aerial work platform made by Anderson Hydra Platforms, and bearing the trademark "Hydra Platform", to be free from defects in material and workmanship.

The obligation and liability under this warranty is expressly limited to repairing or, at Anderson Hydra Platforms option, replacing, free of charge at its factory in South Carolina, any part proving defective under normal use and service within 1 year after said work platform is first placed in service. Replacement will be at no cost after preauthorization.

Parts claimed to be defective and for which repair or Anderson Hydra Platforms replacement is desired shall be if requested by Terex Hydra Platforms, returned, transportation prepaid, to Anderson Hydra Platforms factory for inspection. Replacement parts provided under the terms of this warranty are for the remainder of the warranty period, applicable to the work platform in which they are installed as if such parts were original components of the work platform.

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. 
"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va.
