Addendum #1 - Questions During Pre-Bid Meeting

The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

Correction to the Plans:

- Page 4 of Plans Section P2-P2. The note says Encased in 10 LF (EA) 15" Steel Casing Pipe.
 Should read: Encased in 15 LF (EA) 15" Steel Casing Pipe.
- 2. Page 4 of Plans Section A-A and B-B shows D₅₀ of 12" for the stone. The stone is 12" clean limestone as per Section 8.2.1 of the Specification
- 3. Page 2 of Plans have the wrong Northing and Easting on the survey data. The survey data on page 3 is correct. The correct information for Station #1 is Northing 10000.00 and Easting 10000.00 and for Station #2 the Northing 9830.63 and the easting 100017.81. The correct elevation is Station #1 is 1000.00 and Station #2 is 1001.36.

Corrections to the Specification:

- Now reads: 4.4.2 Payment for Access Road Stone shall be based upon weigh tickets from the commercial supplier of the stone that is delivered and placed at the locations identified on the plan drawings.
 - **Should read: 4.4.2** Payment for Access Road Stone and Gravel Drive Rehabilitation shall be based upon weigh tickets from the commercial supplier of the stone that is delivered and placed at the locations identified on the plan drawings.
- Grout specification in section 7.2.3 will now be: 3 parts sand and 1 part Type II Sulfate Resistant Portland Cement.
 - The minimum required compressive strength of the grout shall be 2000 psi @ 28 days. All testing shall be the responsibility of the contractor as part of Section 3 of these specifications. Two sets (4 cylinders) of test cylinders per day shall serve as a minimum.
- Now reads: 7.2.6 Steel casing will be required for all pipes that run under the railroad grade on site #1. The second mine seal on site #1 has one section of 24" HDPE pipe and will require A.S.T.M. 139 Grade B, 1" thickness 30" round steel casing.
 - Should read: 7.2.6 Steel casing will be required for all pipes that run under the railroad grade on site #1. Portal #1 on site #1 has one section of 24" HDPE pipe and will require A.S.T.M. 139 Grade B, 1" thickness 30" round steel casing.

4. Now reads: Item 9.2 "Bat Gate Mine Seal #3 (Single 48" HDPE Pipe without drainage system.)", per each.

Question #1. Is excavation incidental to the price of the stone on the two buttress' or is it paid separate?

Answer #1. As Per Section 8.1: The excavation is incidental to the cost of the rock which is paid by the ton.

Question #2. What is to be done with the timber that is removed?

Answer #2. Property owner wants the trees windrowed along the road but far enough back from the edge of the road to not block the access.

The Contractor shall have 60 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250.00 per day liquidated damages clause will be in effect after the 60 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.

- 26. TIME: Time is of the essence with regard to all matters of time and performance in this Contract.
- 27. APPLICABLE LAW: This Contract is governed by and interpreted under West Virginia law without giving effect to its choice of law principles. Any information provided in specification manuals, or any other source, verbal or written, which contradicts or violates the West Virginia Constitution, West Virginia Code or West Virginia Code of State Rules is void and of no effect.
- 28. COMPLIANCE: Vendor shall comply with all applicable federal, state, and local laws, regulations and ordinances. By submitting a bid, Vendors acknowledge that they have reviewed, understand, and will comply with all applicable law.
- 29. PREVAILING WAGE: On any contract for the construction of a public improvement. Vendor and any subcontractors utilized by Vendor shall pay a rate or rates of wages which shall not be less than the fair minimum rate or rates of wages (prevailing wage), as established by the West Virginia Division of Labor under West Virginia Code §§ 21-5A-1 et seq. and available at http://www.sos.wv.gov/administrative-law/wagerates/Pages/default.aspx. No Change shall be implemented by the Vendor until such time as the Vendor receives an approved written change order from the Purchasing Division.
- 32. WAIVER: The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or remedy, but the same shall continue in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.

- a. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or
- **b.** The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

53. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products.

This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project.
