Project Description:

Project for the WV Division of Juvenile Services to evaluate and develop construction documents for renovations to the Jones Building, WV Industrial Home for Youth in Industrial, WV. The \$1.2 million project was completed in 2010.

Project work involved accessible entrance ramp and stairs, interior renovations, accessibility improvements, new finishes and ceilings, electrical upgrades, HVAC upgrades, plumbing upgrades, and a new sprinkler system with fire pump and generator.

West Virginia Dept. of Veterans Assistance Donel Kinnard Memorial State Veterans Cemetery

The State of West Virginia selected the team to design the Southern West Virginia Veterans Cemetery, located in Institute, in Kanawha County, West Virginia. The project includes a 2,200 sf public information center/administrative building, a 1,000 sf committal service shelter, and a 2,800 sf maintenance building. The master plan includes over 22,000 casketed and cremain burial gravesites. The State Cemetery accommodates the burials of West Virginia Veterans for 10 years or more, on approximately 300 acres. Master plan of cemetery to be constructed in three phases. Phase One is approximately 40 acres and completed construction in 2012.







Project Description:

Project involved renovations to an old school building located on the grounds of the WV Industrial Home for Youth in Industrial, WV. The purpose of the original study was to determine the feasibility of renovating the structure to again serve as an educational facility.

The final report and cost estimates led to a recommendation to the State of West Virginia to renovate the present building in lieu of constructing a new facility.

Renovations included exterior masonry repair, new roof, new windows, utility, safety, technology, security and cosmetic upgrades.

West Virginia Dept. of Veterans Assistance WV VA 120 Bed Nursing Facility

The team was selected by the State of West Virginia to design the first West Virginia Veterans Nursing Facility. The team utilized the services of WBCM of Baltimore to assist in project planning and programming. The team was asked to complete construction documents in a compressed time frame resulting from the need to meet VA time constraints. Construction documents on the \$22,000,000.00 building were completed within three months and the State benefited from a \$16.3 million dollar grant from the VA. Building construction began in early 2004 with completion in 2008.

One interesting aspect of the 120-Bed facility is the development of a controlled 18-Bed Alzheimer's Unit. These patients are allowed freedom of movement throughout the Unit and all adjacent courtyards. Patient control is maintained by both video and electronic (Wandering Resident System) means.

The team also provided full services for selection and purchasing of interior furnishings and equipment. This portion of work was approximately \$1,750,000.00 - \$2,000,000.00. Ultimately, the Nursing Facility has become a true turnkey project for the State of West Virginia. A similar facility is now planned for Beckley, WV.






The Marion County Health Department Building received a complete renovation of the approximately 24,000 SF, three story building. The Health Department was looking to have exam rooms, waiting room and record storage on the first floor.

The second floor consists of administrative offices. While the third floor is being rented out for private tenant office space. Along with the complete renovation of the existing building and all new HVAC, a complete electrical renovation was done. This electrical service included all new lighting, switches, outlets and other miscellaneous items.

An addition was added to the building that is three stories, and houses the waiting room, egress stair tower and elevator.


