

VECTOR AEROSPACE HELICOPTER SERVICES INC. WARRANTY POLICY

Vector Aerospace Helicopter Services Inc. (Vector) warrants that Vector will repair or replace any aeronautical product repaired or overhauled by Vector for installation in a certified aircraft that is returned to Vector with transportation charges prepaid that has failed or malfunctioned, or at time of delivery, is defective in material or workmanship, subject to each of the following limitations and exclusions:

- 1. The period of this warranty is limited as follows:
 - a) Warranty Coverage against defects in Vector workmanship:
 - i) For work related to airframe (or component thereof) structural repair, avionics & rewire, and other unscheduled repairs —limited to 1 year after receipt of goods, or 500 flight hours of operation, whichever period expires first.
 - ii) For work related to Scheduled aircraft maintenance –limited to next arising of the same scope of maintenance.
 - b) New parts or Equipment incorporated by Vector during repair shall be covered only by each Supplier's or OEM's warranty under the eligibility criteria of their respective policies.
 - c) Vector's obligation to repair a failed or defective aeronautical product is further limited as follows:
 - i) Vector warranty will only be applicable to the area of the aeronautical product that was previously repaired by Vector.
 - ii) Cost of the repair will be borne by Vector up to but not exceeding the cost of the previous repair.
 - iii) Warranty repair charges carried out by a third party will not be honored by Vector without prior written permission. Customer supplied parts or units overhauled by other vendors will be warranted by that party.
- 2. A notice in writing of a warranty claim must be given to Vector no later than 30 (thirty) days after the claimed failure, malfunction, defect, or non-conformity is discovered and the component or accessory must be returned to Vector not later than 90 (ninety) days after such notification is made.
- 3. This warranty shall not apply to failures, malfunctions, defects or non-conformities of aeronautical products, or parts thereof attributable in whole or in part to the failure to preserve, install, operate, maintain, repair, replace or alter the same in accordance with recommendations by the manufacturer, attributable in whole or in part to misuse, neglect or accident including foreign object damage whether in operation, in transit, or in storage.
- 4. THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING AND IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND OF ANY NON-CONTRACTUAL LIABILITIES INCLUDING PRODUCT LIABILITIES BASED UPON NEGLIGENCE OR STRICT LIABILITY, ANY ADDITIONAL OR DIFFERENT LIABILITIES ASSUMED BY VECTOR MUST BE CONTAINED IN WRITING AND SIGNED BY AN AUTHORIZED EMPLOYEE OF VECTOR.
- 5. The obligations of Vector under this warranty are limited to repair or replacement of aeronautical product or parts thereof as provided herein and do not include any remedy or liability for incidental or consequential damages of any kind, whether for damage to airframe or other property, for bodily injury, for costs of expenses of operation on components, for commercial losses or lost profits due to loss of use or grounding of engines or aircraft or otherwise.

In no event, whether as a result of breach of contract or warranty, alleged negligence or otherwise, shall Vector be liable for special or consequential damages including, but not limited to, loss of profits or revenue, loss of use of components or accessories or other equipment, cost of capital, cost of substitute equipment, facilities or services, downtime costs, or claims of customers or buyer(s) for such damages.
