- 11. EXCEPTIONS AND CLARIFICATIONS: The Solicitation contains the specifications that shall form the basis of a contractual agreement. Vendor shall clearly mark any exceptions, clarifications, or other proposed modifications in its bid. - 12. - 13. REGISTRATION: Prior to Contract award, the apparent successful Vendor must be properly registered with the West Virginia Purchasing Division and must have paid the \$125 fee, if applicable.
- 14. UNIT PRICE: Unit prices shall prevail in cases of a discrepancy in the Vendor's bid.
- 15. PREFERENCE: Vendor Preference may only be granted upon written request and only in accordance with the West Virginia Code § 5A-3-37 and the West Virginia Code of State Rules. A Vendor Preference Certificate form has been attached hereto to allow Vendor to apply for the preference. Vendor's failure to submit the Vendor Preference Certificate form with its bid will result in denial of Vendor Preference. Vendor Preference does not apply to construction projects.

- 16. SMALL, WOMEN-OWNED, OR MINORITY-OWNED BUSINESSES: For any solicitations publicly advertised for bid, in accordance with West Virginia Code §5A-3-37(a)(7) and W. Va. CSR § 148-22-9, any non-resident vendor certified as a small, womenowned, or minority-owned business under W. Va. - 17. WAIVER OF MINOR IRREGULARITIES: The Director reserves the right to waive minor irregularities in bids or specifications in accordance with West Virginia Code of State Rules § 148-1-4.6.
- 18. ELECTRONIC FILE ACCESS RESTRICTIONS: Vendor must ensure that its submission in wvOASIS can be accessed by the Purchasing Division staff immediately upon bid opening. - 2.2. "Bid" or "Proposal" means the vendors submitted response to this solicitation.
- 2.3. "Contract" means the binding agreement that is entered into between the State and the Vendor to provide the goods or services requested in the Solicitation.
- 2.4. "Director" means the Director of the West Virginia Department of Administration, Purchasing Division.
- 2.5. "Purchasing Division" means the West Virginia Department of Administration, Purchasing Division.
- 2.6. "Award Document" means the document signed by the Agency and the Purchasing Division, and approved as to form by the Attorney General, that identifies the Vendor as the contract holder.
- 2.7. "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.

Any waiver must be expressly stated in writing and signed by the waiving party.

Notwithstanding the foregoing, Purchasing Division approval may or may not be required on certain agency delegated or exempt purchases.
- 26. WARRANTY: The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- 27. STATE EMPLOYEES: State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- 28. BANKRUPTCY: In the event the Vendor files for bankruptcy protection, the State of West Virginia may deem this Contract null and void, and terminate this Contract without notice.

- 29. PRIVACY, SECURITY, AND CONFIDENTIALITY: The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. - 30. YOUR SUBMISSION IS A PUBLIC DOCUMENT: Vendor's entire response to the Solicitation and the resulting Contract are public documents. As public documents, they will be disclosed to the public following the bid/proposal opening or award of the contract, as required by the competitive bidding laws of West Virginia Code §§ 5A-3-1 et seq., 5-22-1 et seq., and 5G-1-1 et seq. and the Freedom of Information Act West Virginia Code §§ 29B-1-1 et seq.

DO NOT SUBMIT MATERIAL YOU CONSIDER TO BE CONFIDENTIAL, A TRADE SECRET, OR OTHERWISE NOT SUBJECT TO PUBLIC DISCLOSURE.

Submission of any bid, proposal, or other document to the Purchasing Division constitutes your explicit consent to the subsequent public disclosure of the bid, proposal, or document. The Purchasing Division will disclose any document labeled "confidential," "proprietary," "trade secret," "private," or labeled with any other claim against public disclosure of the documents, to include any "trade secrets" as defined by West Virginia Code § 47-22-1 et seq. All submissions are subject to public disclosure without notice.

- 31. LICENSING: In accordance with West Virginia Code of State Rules § 148-1-6.1.e, Vendor must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agency or political subdivision. Upon request, the Vendor must provide all necessary releases to obtain information to enable the Purchasing Division Director or the Agency to verify that the Vendor is licensed and in good standing with the above entities.
- 32. ANTITRUST: In submitting a bid to, signing a contract with, or accepting a Award Document from any agency of the State of West Virginia, the Vendor agrees to convey, sell, assign, or transfer to the State of West Virginia all rights, title, and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of West Virginia for price fixing and/or unreasonable restraints of trade relating to the particular commodities or services purchased or acquired by the State of West Virginia. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to Vendor.

33. 35. VENDOR RELATIONSHIP: The relationship of the Vendor to the State shall be that of an independent contractor and no principal-agent relationship or employer-employee relationship is contemplated or created by this Contract. The Vendor as an independent contractor is solely liable for the acts and omissions of its employees and agents. Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

- 36. INDEMNIFICATION: The Vendor agrees to indemnify, defend, and hold harmless the State and the Agency, their officers, and employees from and against: (1) Any claims or losses for services rendered by any subcontractor, person, or firm performing or supplying services, materials, or supplies in connection with the performance of the Contract; (2) Any claims or losses resulting to any person or entity injured or damaged by the Vendor, its officers, employees, or subcontractors by the publication, translation, reproduction, delivery, performance, use, or disposition of any data used under the Contract in a manner not authorized by the Contract, or by Federal or State statutes or regulations; and (3) Any failure of the Vendor, its officers, employees, or subcontractors to observe State and Federal laws including, but not limited to, labor and wage and hour laws.
- 37. Any extension of this Contract to the aforementioned Other Government Entities must be on the same prices, terms, and conditions as those offered and agreed to in this Contract, provided that such extension is in compliance with the applicable laws, rules, and ordinances of the Other Government Entity. If the Vendor does not wish to extend the prices, terms, and conditions of its bid and subsequent contract to the Other Government Entities, the Vendor must clearly indicate such refusal in its bid. A refusal to extend this Contract to the Other Government Entities shall not impact or influence the award of this Contract in any manner.
- 39. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

41. BACKGROUND CHECK: In accordance with W. Va. Code § 15-2D-3, the Director of the Division of Protective Services shall require any service provider whose employees are regularly employed on the grounds or in the buildings of the Capitol complex or who have access to sensitive or critical information to submit to a fingerprint-based state and federal background inquiry through the state repository. The service provider is responsible for any costs associated with the fingerprint-based state and federal background inquiry.

After the contract for such services has been approved, but before any such employees are permitted to be on the grounds or in the buildings of the Capitol complex or have access to sensitive or critical information, the service provider shall submit a list of all persons who will be physically present and working at the Capitol complex to the Director of the Division of Protective Services for purposes of verifying compliance with this provision. The State reserves the right to prohibit a service provider's employees from accessing sensitive or critical information or to be present at the Capitol complex based upon results addressed from a criminal background check.

- 42. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:
  - a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001. b. "Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
  - c. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or
  - d. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

43. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. This provision only applies to public works contracts awarded in an amount more than fifty thousand dollars (\$50,000) or public works contracts that require more than ten thousand pounds of steel products.

The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

# ADDITIONAL TERMS AND CONDITIONS (Construction Contracts Only)

1. CONTRACTOR'S LICENSE: West Virginia Code § 21-11-2 requires that all persons desiring to perform contracting work in this state be licensed. The West Virginia Contractors Licensing Board is empowered to issue the contractor's license. Applications for a contractor's license may be made by contacting the West Virginia Division of Labor. West Virginia Code § 21-11-11 requires any prospective Vendor to include the contractor's license number on its bid. Failure to include a contractor's license number on the bid shall result in Vendor's bid being disqualified. Vendors should include a contractor's license number in the space provided below.

- 2. DRUG-FREE WORKPLACE AFFIDAVIT: W. Va. Code § 21-1D-5 provides that any solicitation for a public improvement contract requires each Vendor that submits a bid for the work to submit at the same time an affidavit that the Vendor has a written plan for a drug-free workplace policy. To comply with this law, Vendor must either complete the enclosed drug-free workplace affidavit and submit the same with its bid or complete a similar affidavit that fulfills all of the requirements of the applicable code. Failure to submit the signed and notarized drug-free workplace affidavit or a similar affidavit that fully complies with the requirements of the applicable code, with the bid shall result in disqualification of Vendor's bid. Pursuant to W. Va. Code 21-1D-2(b) and (k), this provision does not apply to public improvement contracts the value of which is \$100,000 or less or temporary or emergency repairs.
- 2.1. DRUG-FREE WORKPLACE POLICY: Pursuant to W. Va. Code § 21-1D-4, Vendor and its subcontractors must implement and maintain a written drug-free workplace policy that complies with said article. The awarding public authority shall cancel this contract if: (1) Vendor fails to implement and maintain a written drug-free workplace policy described in the preceding paragraph, (2) Vendor fails to provide information regarding implementation of its drug-free workplace policy at the request of the public authority; or (3) Vendor provides to the public authority false information regarding the contractor's drug-free workplace policy.

- 3. DRUG FREE WORKPLACE REPORT: Pursuant to W. Va. Code § 21-1D-7b, no less than once per year, or upon completion of the project, every contractor shall provide a certified report to the public authority which let the contract. The report shall include:

4. AIA DOCUMENTS: All construction contracts that will be completed in conjunction with architectural services procured under Chapter 5G of the West Virginia Code will be governed by the AIA A101-2007 and A201-2007 or the A107-2007 documents, as amended by the Supplementary Conditions for the State of West Virginia, in addition to the terms and conditions contained herein.

- 5. SUBCONTRACTOR LIST SUBMISSION: In accordance with W. Va. Code § 5-22-1, The apparent low bidder on a contract for the construction, alteration, decoration, painting or improvement of a new or existing building or structure valued at more than \$250,000.00 shall submit a list of all subcontractors who will perform more than \$25,000.00 of work on the project including labor and materials. This provision shall not apply to any other construction projects, such as highway, mine reclamation, water or sewer projects. Additionally, if no subcontractors who will perform more than \$25,000.00 of work are to be used to complete the project, it will be noted on the subcontractor list.
  - a. Required Information. The subcontractor list shall contain the following information:
  - i. Bidder's name
  - ii. Name of each subcontractor
  - iii. License numbers as required by W. Va. Code § 21-11-1 et. seq.
  - iv. Notation that no subcontractor will be used to perform more than \$25,000.00 of work, when applicable
  - b. Submission. The completed subcontractor list shall be provided to the Purchasing Division within one business day of the opening of bids for review. Failure to submit the subcontractor list within one business day after the deadline for submitting bids shall result in disqualification of the bid.

Unit before any subcontractor substitution is permitted. Substitutions are not permitted unless:

- i. The subcontractor listed in the original bid has filed for bankruptcy;

- iii. The contractor certifies in writing that the subcontractor listed in the original bill fails, is unable, or refuses to perform his subcontract.
- 6. GREEN BUILDINGS MINIMUM ENERGY STANDARDS: In accordance with § 22-29-4, all new building construction projects of public agencies that have not entered the schematic design phase prior to July 1, 2012, or any building construction project receiving state grant funds and appropriations, including public schools, that have not entered the schematic design phase prior to July 1, 2012, shall be designed and constructed complying with the ICC International Energy Conservation Code, adopted by the State Fire Commission, and the ANSI/ASHRAE/IESNA Standard 90.1-2007: Provided, That if any construction project has a commitment of federal funds to pay for a portion of such project, this provision shall only apply to the extent such standards are consistent with the federal standards.

### **SPECIFICATIONS**

- PURPOSE AND SCOPE: The West Virginia Purchasing Division is soliciting bids on behalf of the West Virginia Lottery ("Lottery") located at 900 Pennsylvania Avenue, Charleston, WV 25302 to establish an open-end contract for preventive (monthly) maintenance and corrective (as-needed) elevator maintenance services on the Lottery's four (4) elevators.
- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
  - 2.1 "Contract Services" means the preventive and corrective elevator maintenance services as more fully described in these specifications.
  - 2.2 "Pricing Page" means the pages, contained wvOASIS or attached hereto as Attachment A, upon which Vendor should list its proposed price for the Contract Services (see extensive instructions in Section 5.2)
  - 2.3 "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
- 3. QUALIFICATIONS: Vendor shall have the following minimum qualifications:
  - 3.1 The Vendor or its employees designated to perform under this contract must have Five (5) years' experience installing and/or maintaining equipment of similar manufacturer and type listed in Attachment B of this RFQ. Vendors should provide documentation to demonstrate that they meet this requirement with their bid, but it is required prior to award. Documentation may include, but is not limited to: copies of contracts, references which can verify the adequate numbers of years, ANSI Accreditations, etc.
  - 3.2 The Vendor shall provide copies of the certifications including, but not limited to, NEIEP (National Elevator Industry Educational Program), or equal, for all elevator mechanics directly employed and supervised by the Vendor. The Vendor shall provide this documentation to the Agency Operations and Maintenance Manager prior to any mechanic performing work under this contract. Copies of certifications for mechanics intended to be used to fulfill the Vendor's responsibilities under this Contract should be provided with the bid, but must be provided prior to award.
  - 3.3 The Lottery requires and will perform a criminal background check for each Vendor employee, as well as the employees of all sub-Vendors, who will be required to enter the State of West Virginia office building as part of this project. The Lottery will not allow any Vendor or sub-Vendors access to the building until

the background checks are completed and acceptable. At the beginning of the contract the Vendor will provide the Lottery with the names, home addresses, home contact numbers, and work assignments of each employee who will be working under the contract for criminal background investigation purposes. Any changes, deletions, or additions to this list will be furnished immediately as they occur to the Lottery.

3.4 Compliance with experience requirements will be determined prior to contract award by the State through references provided by the Vendor with its bid or upon request, through knowledge or documentation of the Vendor's past projects, or some other method that the State determines to be acceptable. Vendor must provide any documentation requested by the State to assist in confirmation of compliance with this provision. References, documentation, or other information to confirm compliance with this experience requirement are preferred with the bid submission, but may be requested after bid opening and prior to contract award.

## 4. MANDATORY REQUIREMENTS:

- 4.1 Mandatory Contract Services Requirements and Deliverables: Contract Services must meet or exceed the mandatory requirements listed below.
  - 4.1.1 Preventive / Full Service Maintenance: Vendor must perform preventive / full service maintenance for a flat monthly fee per elevator. It will include monthly inspections, replacement of parts, components, and material on elevator components or equipment on a pre-planned schedule prior to the failure or wear-out period of the part, component, or materials and maintenance due to mechanical breakdown as a result of normal wear and tear. The planned inspections and replacement of parts, components, and material shall be in accordance with the equipment manufacturer's specifications and recommendations or in accordance with National Code requirements.
    - 4.1.1.1 Within Five (5) business day of award of Contract, Vendor must provide a monthly schedule of all planned preventive / full service maintenance visits. Vendor shall make routine examinations and maintenance at least once a month for each elevator.
    - **4.1.1.2** Additional preventive / full service maintenance: Vendor must perform the following tasks as part of its preventive / full service maintenance program in addition to those listed above.
      - 1. Keep controllers and hoist motors free of dirt, dust, and oil;
      - 2. Change seals as needed to prevent leakage;
      - 3. Keep generators free of dirt, dust, and oil;

- 4. Change brushes on an as needed basis to prevent commutator damages;
- 5. Refill gear cases and lubricators as needed;
- 6. Keep oil reservoirs properly sealed to prevent leakage;
- 7. Sweep machine room floors each time upon exiting for the final time
- 8. Clean hoistway doors, tracks, hangers, guide shoes or rollers and relating cables annually and change them as needed;
- 9. Lubricate guide rails except for roller guide installations;
- 10. Lubricate all overhead sheaves every six months
- 11. Clean all pits as needed.
- 12. Clean and lubricate all compensating sheaves, cables, chains, and bearings
- 13. Vendor shall clean all car tops every six months.

- 16. Vendor must maintain all door opening and closing speed and thrust.
- 17. Vendor must test the fire service of each elevator and record in the machine room every thirty (30) days. This must include emergency lights, alarms, telephones, fire recall and emergency recall.
- 18. Vendor must examine all suspension ropes, compensating ropes and governor lines and change as needed per code.
- 19. Vendor must replace or make corrections to any parts or equipment listed below due to age, normal wear and tear, frequent mechanical breakdowns, or for any safety reasons:

- 1. Computers, PLC's, video monitors.
- m. PLC's software of hardware.
- Hydraulic power units, pumps and valves.
- o. Hydraulic fluid, fluid reservoirs, heater for oil reservoirs.
- p. Operating valves, manual and automatic.
- Pistons and their packing.
- r. Mufflers and silencers.
- s. Pipe and pipe fittings located above ground.
- t. Control wiring, electric wiring, fuses.
- u. Guide shoes and rollers.
- v. Control cables, wire ropes and cables.
- w. Hoisting and governor cables and their fastenings.
- x. Drive, governor, deflector, and compensating devices.
- y. Car and overweight safeties.
- z. Overspeed governors, buffers, and their contacts.
- aa. Limit, landing, leveling and slow down switches, emergency lowering devices.
- bb. Anti-Creep devices.
- cc. Operating buttons and switches including key type.
- dd. Hatch door interlocks, gate and door controls.
- ee. Door and gate operating equipment, grates.
- ff. Door protective devices.
- gg. Load weighting and dispatching devices.
- hh. Compensating cables or chains.
  - ii. Position and speed encoders.
- jj. Indicator lamps and indicator LED's.
- kk. Car Station telephones.
- II. Batteries for any and all equipment.
- mm. Remote monitoring devices.
- nn. Cylinders and casings.
- oo. Hoistway gates, door, frames and seals, enclosures.
- pp. Emergency car lights.
- qq. Cover plates for signals, signal bells, and signal systems.
- rr. Communication systems (intercoms), telephone cables.

ss. Main line power switches, breakers and feeders to elevator control equipment, and any other mechanical features of the elevators.

### 20. Vendor must maintain:

- a. Hall buttons.
- b. Alarms, and emergency telephone equipment.
- c. Lamps and fixtures (excluding car lighting).
- d. Car operating panels, buttons, and lamps.
- e. Position indicators and lamps.
- f. Legally required public signage (ie ADA, NFPA, and DOL certificates).
- Vendor must include restarting and/or reprograming elevators after power outages or temporary interruptions in electrical service.
- 22. Vendor must arrive on site within 1 hour of any entrapment incident to begin work to free the trapped individual.
- 23. Vendor must arrive on site within 2 hours of being called to diagnose elevator problems.
- 24. If Vendor diagnoses an elevator problem and determines the elevator can be repaired to working order with anything that is included in preventive / full service maintenance, then Vendor is obligated to perform those repairs as preventive / full service maintenance.
- 25. Vendor will be required to re-program elevator telephones when necessary.
- 4.1.1.3 Inspection and Testing: Vendor shall conduct inspections and testing of all elevators in accordance with then current state and federal laws, codes, or regulations. Inspection and testing services are included in preventive / full service maintenance and shall be covered under the flat monthly rate. Vendor will be held responsible for any damage that may occur to any of the elevators or the building due to failure to properly conduct inspections and testing.
  - Vendor must arrange and perform all 5 year full load safety tests, all annual no load safety tests, and all I hydraulic relief tests.
     Vendor shall file the proper tags with the Division of Labor.
  - Vendor must complete any repairs deemed necessary by the assigned Labor and Industry Elevator Inspector, WV approved third party inspector and/or designated WV elevator consultant.

Vendor shall have 30 days to complete these repairs or obtain a waiver from the WV Division of Labor. Repairs under this provision will be included in the monthly rate for preventive / full service maintenance if the repair is included in preventive / full service maintenance or as Corrective Maintenance if it is not included in the preventive / full service maintenance.

- 3. Vendor will be required to perform all safety tests for all certified third party inspectors. The Agency will be responsible for all costs for third party inspectors' and payment to the Division of Labor for all certification fees.
- 4.1.2 Exclusions from Preventive / Full Service Maintenance: For the purpose of clarification, any item not specifically excluded above shall be the Vendor's responsibility under the scope of the preventive / full service maintenance. Preventive / full service maintenance does not include repair or replacement of carpets and applied floor coverings, wall board and panel, underground piping for hydraulic elevators and any enhancements to existing equipment or new installations not required to keep the car in operation.

Preventive / full service maintenance also does not include maintenance or adjustments required due to vandalism or misuse. Maintenance or adjustments required due to vandalism or misuse would be considered Open End Service and must be approved by the Agency.

Restarting or programing the elevator after a power outage shall not be considered misuse and is included in preventive / full service maintenance.

- 4.1.3. Corrective Maintenance: Vendor shall provide Corrective Maintenance on an as requested basis for an hourly fee established in this Contract with parts provided at Vendor's cost. No individual Corrective Maintenance Service request will be issued by the Agency under any circumstances if the individual project's total cost will exceed \$25,000.00.
  - 4.1.3.1. Diagnosis and Cost Estimate Vendor is required to provide a diagnosis of all elevator problems and a cost estimate to perform the needed corrective maintenance repair. The diagnosis and cost estimate are included in the preventive / full service maintenance provisions of this contract.

The agency will use the cost estimate to ensure that it does not authorize corrective maintenance for any individual project that exceeds \$25,000.

The cost estimate must include the intended scope of work itemized by labor and parts cost.

- 4.1.3.2. Response Time: Vendor is required to arrive on site within two (2) hours of being notified of a problem by the Agency to diagnose the problem. Vendor must begin repairs as soon as possible, but no later than 24 hours after being notified of the problem. The deadline to respond on-site may only be waived or extended by written approval of the Agency.
- 4.1.3.3. Authorization to Work: Upon receiving the cost estimate for the corrective maintenance, the Agency will determine if the cost of the project is less than \$25,000. If the cost is less than \$25,000, the agency will define the scope of work to be performed and issue a Delivery Order authorizing the Vendor to perform the work.
- 4.1.4. Parts, Tools, and Equipment: The Vendor shall provide and install all parts, components, and materials to keep equipment operating in accordance with manufacturer's specifications.
  - **4.1.4.1. Tools and Equipment:** The Vendor shall provide all tools, and accessories, personal safety equipment, and supplies necessary to execute the responsibilities of this contract at no cost to the Agency.
  - **4.1.4.2.** Consumables: Non-reusable parts, components, and materials used in the scope of performing under this Contract shall be supplied by the Vendor at no cost to the Agency. Such items shall include, but not be limited to, grease, cleaning supplies and rags.
  - 4.1.4.3. Third Party Repairs: Third-party service required to repair parts or components (eg, motor rewinding, etc) can be charged as other parts, using the third-party vendor invoice total as the parts cost and any parts mark-up included in this Contract. Agency must pre-approve any parts charges.
  - 4.1.4.4. Disposal: Vendor is responsible of disposal of all replaced parts, oils, or anything relating to elevators. Such disposal shall comply with all applicable EPA (Environmental Protection Agency) standards.
  - 4.1.4.5. Parts for Preventive / Full Service Maintenance: Vendor must provide parts, components and materials used for Full Service Maintenance, as part of the Flat Monthly Rate.
  - 4.1.4.6. Parts for Corrective Maintenance: Vendor shall provide parts, components and materials used for all corrective maintenance requests, at the cost of the parts plus any mark-up included in this Contract.
- 4.1.4.7. Warranty: Vendor shall furnish a twelve (12) month warranty on parts, or the minimum manufacturers' warranty whichever is longer.

- **4.1.4.8. Freight Charges:** Vendor will be responsible for all freight charges incurred as a result of the purchase of replacement parts under this Contract. No markup shall be permitted for expedited delivery.
- 4.1.5. Permitted Working Hours: Under normal circumstances, excluding entrapments, Vendor shall perform all Full Service and Open-End Services during normal business hours (Monday through Friday 8:00am to 5:00pm EST, excluding holidays.) The holidays to be excluded are New Years' Day, MLK Day, President's Day, Memorial Day, WV Day, Independence Day, Labor Day, Veterans Day, Thanksgiving, Friday after Thanksgiving, Christmas Eve, and Christmas Day and New Years' Eve. Hours of work performed outside normal business hours shall be approved by the Agency with written notification.
- 4.1.7 Removal from Service: Only under emergency situations will the Vendor remove an elevator from service without prior approval from the Agency. Under no circumstances will an elevator be out of service for more than a 24 hour period unless the Vendor has obtained written approval from the Agency. If a longer period is required for repairs, Vendor must coordinate with the Agency in advance so downtime will be scheduled accordingly.
- 4.1.8 Deductions: Should any elevator covered by this contract be permanently removed from service, the Vendor shall reduce the Total Monthly Charge by the Monthly Cost in effect at the time of the removal from service for each elevator so removed. In this case the Agency will notify the Vendor in writing and will remove the elevator from coverage the first day of the next month.
- 4.1.9 Labor Warranty: The Vendor shall furnish a warranty of 12 months for all labor performed under this Contract.

### 5. CONTRACT AWARD:

- 5.1 Contract Award: The contract is intended to provide Agency with a purchase price for Contract Services. The Contract shall be awarded to the Vendor that provides the Contract Services meeting the required specifications for the lowest overall Total Bid Amount as shown on the Pricing Pages (Item D, the total of Items A, B & C on Attachment A; or, the Total Bid in wvOasis).
- 5.2 Pricing Pages: Vendor should complete the Pricing Pages by completing all cost information and completing contact information on Exhibit A within this Request for Quotations. Vendor should complete the Pricing Pages in their entirety as failure to do so may result in Vendor's bids being disqualified.

### FLAT MONTHLY RATE

Bidders should provide a Monthly Cost for each Elevator, to include all associated costs to provide Preventive / Full Service Maintenance. The bid Monthly Cost should be multiplied times 12 to calculate the Extended Yearly Cost for each elevator. Bidders should total all (4) Yearly Costs to calculate the Total Yearly Charge (Item A on Exhibit A).

### FLAT HOURLY RATE

Bidders should provide a single Flat Hourly Rate to cover Corrective Maintenance. The Quantity of fifty (50) hours is provided as an estimate only, used only for evaluating bids. No guaranteed quantity of requested hours is assumed, provided, or implied. Agency must pre-approve any hourly rate charges. Bidders should multiply their bid Flat Hourly Rate times the Quantity of fifty (50) to calculate the Extended Cost (Item B on the Exhibit A Pricing Page).

#### **PARTS MARKUP**

Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.
- 8. TRAVEL: Vendor shall be responsible for all mileage and travel costs, including travel time,

associated with performance of this Contract. Any anticipated mileage or travel costs may be included in the flat fee or hourly rate listed on Vendor's bid, but such costs will not be paid by the Agency separately.

  - 10.1.3 Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.
  - 10.1.4 Failure to remedy deficient performance upon request.
- 10.2 The following remedies shall be available to Agency upon default.
  - 10.2.1 Cancellation of the Contract.
  - 10.2.2 Cancellation of one or more release orders issued under this Contract.
  - 10.2.3 Any other remedies available in law or equity.

### 11. MISCELLANEOUS:

11.1 No Substitutions: Vendor shall supply only Contract Services submitted in response to the RFQ unless a contract modification is approved in accordance with the provisions contained in this Contract.
