Addendum #1
Questions and Answers

Q1: Will the tree trimming work be limited to state office buildings?

A1: The work is limited to locations owned by DHHR.

Q2: Will Davis-Bacon Act wages apply to this contract?

A2: Yes.

Q3: On the pricing page, shall the price quoted be per man-hour, inclusive of all necessary equipment, or by the crew hour – two or three-man crew?

- Aerial bucket crews are more efficient and productive than climbing crews. Their hourly rates are higher, but their productivity per hour is much greater.

A3: The hourly rate bid price shall include all labor, materials, and necessary equipment to complete the work.

Q4: Is the final award based on price only, or will a provider's qualifications, experience and references be considering factors?

A4: The contract will be awarded to the Vendor that submits the lowest bid that also meets the required specifications.

Q5: Is a vendor required to bid on all regions, or can we opt-out of certain regions?

A5: Vendors are not required to bid on all regions. Vendors may bid on one or multiple regions.

Q6: The listed estimated hours is 50 per region, is this an estimate for the contract per region?

A6: Fifty hours is used as a calculation to determine the overall bid price for the contract award recommendation.

Q7: Is this anticipated to be day work (removal of one or two trees at a time) or multiple projects at one time taking several days to complete?

A7: Each location will be recognized as one project regardless of the amount of work to be completed.

Q8: Is there a minimum price or number of hours per job?

A8: No, each job is based on hours worked.

Q9: The regions are quite large with areas that are several hours apart. My concern is that we may be call out to an area 2 hours away for a one hour job. In this scenario we would have 5 hours in a job and just be able to bill 1 hour. I would think there should be a one day minimum or at least a half day minimum to help cover travel and set up cost? Can you shed some light on this?

A9: The hourly rate bid price shall include all labor, materials, and necessary equipment to complete the work; therefore, travel and set up costs should be factored into the hourly wage bid submission.

Q10: On the oasis website it is listed as quantity 50.0 trees but in the attached document it is bid out as 50.0 hours. We were wondering if you would clarify. If it is 50 hours, it is over the period of a year, week, or month? If it is 50 trees, do you already have the trees selected?

A10: Fifty hours is used as a calculation to determine the overall bid price for the contract award recommendation.

Q11: Would we be needed on a weekly basis or just when you have a tree service need?

A11: When DHHR has a tree service need.
