This Statement of Work ("SOW"), dated Thursday, 09 February 2017 is by and between West Virginia Department of Health and Human Resources ("Customer") and Experian Marketing Solutions, LLC ("Experian Data Quality") and is entered into pursuant to the Experian Data Quality Standard Terms and Conditions. This SOW is hereby made a part of, and is subject to the terms and conditions of the Agreement. To the extent that there is any conflict or inconsistency between the terms and conditions contained in this SOW and those set forth in the Agreement, the terms and conditions contained herein shall prevail. Capitalized terms not specifically defined herein shall have the meaning set forth in the Agreement.

This project is referenced on the Quotation as "Professional Services - Integration Consulting – Pro Web".

1. Overview

The goal of this project is to provide the Customer direct access to resources within Experian Data Quality who are experienced with integrating Pro Web and Pro API. An Experian Data Quality Consultant ("Consultant") and project manager will work to ensure that the project meets the Customer's business and technical requirements and is executed as efficiently as possible.

The Consultant will participate in the relevant project planning, design, and technical sessions by phone or video conference. The Consultant will make those meetings effective by helping to clarify an appropriate agenda, providing supporting documents, and providing advice based on their past integration experience. Once the solution is developed by the Customer, the Consultant will test it for usability and against known address formats.

2. Deliverables

The following items shall be delivered by Experian Data Quality during this project:

- a. Experian Data Quality will provide a Consultant on the installation and configuration of Pro Web and Pro API.
 - i. The customer is currently using Pro Web 5.62 and Pro API 5.30. The Customer will be upgrading to the most recent versions of Pro Web and Pro API.
 - ii. Pro Web Upgrade
 - i. The Consultant will advise on the installation of the new versions on Windows Server 2012.
 - ii. The Pro Web existing integration used the C# common classes and contains multiple touchpoints. The Consultant will advise on a single touchpoint. Any further touchpoints may require a Change Order.
 - iii. Pro API Upgrade
 - i. Pro API is built into Powerbuilder using a client-server configuration.
 - ii. The Consultant will advise on the installation and configuration of Pro API.
 - iii. The Consultant will advise on a single touchpoint. Any further touchpoints or modifications may require a Change Order.
- b. The following country/countries will be included in this integration: USA.
- c. The following data attributes will also be used: address verification data only.
- d. The Consultant is responsible only for support of the core functionality of Pro Web and is not responsible for any integration or coding components of the Customer's application. The Consultant is not responsible for product issues resulting from the Customer's environment or application.
- e. The Customer will provide the necessary resources including but not restricted to: Project Manager, Developer, Database Administrator, or Technical Architect.

3. Fee

This section outlines the fee associated with this project.

- a. The project will be billed at \$5,000.00.

4. Project Timing

This section outlines the timing estimate established for this project.

- a. The project will start up to three (3) weeks after a written, electronic request to start has been received from the Customer by Experian Data Quality.
 - i. If no receipt of a written, electronic request to start has been received within fourteen (14) days from the Customer, an Experian Data Quality Project Manager will contact the provided Customer contact via email and/or phone, dependent on information provided.
- b. Consultant hours may be scheduled based on availability from 8AM-5PM EST for business days with the exception of the following holidays: New Year's Day, Martin Luther King Day, President's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, the Friday after Thanksgiving Day, Christmas Eve, Christmas Day, and New Year's Eve and New Year's Day. Holidays are subject to change based on corporate policy.

5. Change Orders

- a. Project changes outside of the scope of the Deliverables or Assumptions will be documented in a Change Order. Change Orders will serve to formally modify the scope, cost or timeline of this SOW. All Change Orders will need to be agreed upon and signed by Experian Data Quality and Customer before the work is performed.
- b. Change Orders are subject to scope review and may impact the project timeline or fee. The Customer may be charged a fee to be determined per the scope of the change required.

6. Project Assumptions

The following are the assumptions related to this SOW:

- a. All coding required for the integration will be performed by the Customer.
- b. Prior to the start of the project, the Customer will confirm in writing the business and technical requirements of the project.
- c. Customer will provide one project management resource that is empowered to set schedules and allocate resources within the Customer's operation.
- d. Experian Data Quality Consultant will be provided with necessary access to the Customer's system and/or infrastructure for testing and troubleshooting purposes. This is typically achieved via an online collaboration / screen-sharing technology.
- e. All Consultant work is expected to be performed remotely from Experian Data Quality offices.
 - i. If the Customer requests any onsite work, travel expenses incurred by Experian Data Quality or its subcontractors are to be reimbursed by the Customer.
 - ii. If the Customer requests any onsite work, three (3) week notice from the Customer must be provided before any scheduled travel occurs.
- f. All Consultant work may be recorded at the request of the Customer prior to the start of any scheduled sessions
- g. Experian Data Quality will not be responsible for moving implementation from a testing to production environment, and will not make any changes in Customer's production environment.
- h. After project close, Consultant and Project Manager will transition Customer to Technical Support team for on-going support.

7. Completion Criteria

This project will be considered complete when one of the following criteria is met. Once one of these is met, no further work will be completed on this SOW. If additional work is required, a Change Order or new Statement of Work must be generated.

- a. More than six (6) months has passed since the date of signature of the SOW and the failure to complete within such timeframe is the sole fault of Customer.
