
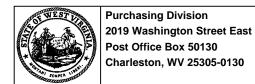

- AS. A newer version of the 2951 would be a better option due to the mandatory requirement of a 5 year warranty is required.
