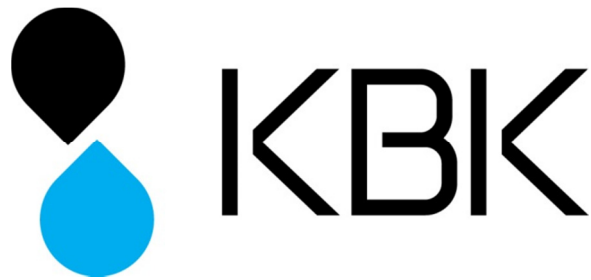

In no event shall such notification be received by Seller later than sixty (60) months from the date of delivery. Within a reasonable time after such notification, Seller will correct any defect in material or workmanship with replacement parts. Such repair including both parts and labor is at Seller's expense. If Seller is unable to repair the product after reasonable attempts, Seller will provide, at its option one of the following: (a) a replacement, or (b) full refund of the purchase price to Purchaser. These remedies are the Purchaser's exclusive remedies for breach of warranty.

In no case shall Seller be liable for any special, incidental, or consequential damages based upon breach of warranty, breach of contract, negligence, strict tort, or any other legal theory. Such damages include, but are not limited to, loss of profits, loss of savings or revenue, loss of use of the product or any associated equipment, cost of capital, cost of substitute equipment, facilities or services, downtime, the claims of third parties including customers, and injury to property. Any action of breach of warranty must be commenced within sixty (60) months following delivery of a product.

THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
